2. No place in the IRC is there any law that makes most American's liable for "income" taxes. It simply doesn't exist.

3. The 1040 form is a "bootleg" form that violates the Office of Management and Budget (OMB) laws regarding the use of OMB numbers that are required to make this "collection of information form" legal, and something you have to fill out and "return." <http://www.thematrixhasyou.org/affidavit-updated/attachment-d-u.html>

4. Colorado Department of Revenue (CDR) taxation is based on Federal tax forms.

We want to have three basic purposes for the paper:

1. Have a section of the FP devoted to all our county

2. Have a section devoted to what is called "Redress of Grievance." This stems from our Constitutional right under the First Amendment to demand of our servant government answers to issues we have with any aspect of it;

We believe that in order for citizens to have an active say in what is going on, they need to have accurate, complete and truthful information upon which to rely and to make an informed decision.

NOTICE to County Recorder & Banks

The following brief discussion will be sent to all County Banks and the County Recorder in a much expanded form as respective NOTICES of violations of lien and levy laws, possible Securities Fraud, and deprivation of rights taking place on a regular basis against County Citizens. The final letters will be printed in their entirety in a future edition of the Free Press for public discussion and action!

Most banks and County Recorders across the country are involved with multiple violations of law. The following is a list of violations taking place against county citizens, and need to stop immediately or legal action will be taken as part of a Grand Jury or Private Attorney's General Investigation.

Many County citizens have been the victims of such actions, and must know that they have been acted upon in violation of law and the Constitution, and their property stolen and their credit damaged under color of law.

1. Banks, and June Madrid, the County Recorder, have received “Notice Of Levy” or “Notice of Lien” from the Internal Revenue Service (IRS), or Colorado Department of Revenue (CDR) served against our citizens, and are processing such documents as actual Liens or Levies, which they are not. Only “Perfected” Liens and Levies can legally be acted upon by any bank institution or government office which has fiduciary responsibility to citizens of Archuleta County. The act of taking a “Notice” of lien or levy and turning it into an actual Perfected “Lien” or “Levy” (“Perfected” only through court proceedings and having a judge's signature), is a Securities Fraud, whereby a non-negotiable instrument, with no lawful backing it, is turned into a financial instrument, under color of law, and is “conversion” of property, which is a felony.

2. Banks routinely require your Social Security Number (SSN) for opening a bank account. First off, our SSN cannot be used for “Identification Purposes,” as the card and literature that comes with such cards plainly state. Second, Banks are NOT employees of the IRS or CDR or any other agency, and are NOT required to be acting as reporting agents for them. Third, to deprive any citizen who has a non-interest bearing account, at the least, is acting under the color of law, and demanding a SSN to be able to open a personal or business account is unlawful. The laws on this are plain, and no bank can act in this manner without creating a liability against themselves.

3. Any house or other property taken as part of such activity is done so

illegally and unconstitutionally. Such property can be regained, and suit can be brought against all parties to such action... even those who purchase such property unaware of the illegal actions taking place, or the judge's who play the same illegal game. All such action is fraud, and the courts are participating in such fraud, and there is NO statute of limitations on Fraud on the Court. This means there is recourse against ALL parties at ANY time in the future.

The FP will be seeking banks which we can support, or we will locate a bank and invite them into Pagosa Springs and Archuleta County so citizens can be safe and secure in their financial affairs without fear of betrayal by conforming to agencies which routinely break the law.

The FP will also be aggressively seeking correction to this illegal activity by the County Recorder, June Madrid, who has been warned repeatedly for years of this, yet has ignored it. You can run, but you can't hide!

If you have been the victim of any of this activity, we want to hear from you and document this as part of the greater ongoing investigations taking place in this county. Simply write up your experience in what is called an “affidavit,” provide your contact information in the affidavit, take it to a Notary, and sign it in their presence. Make a copy of it, and send the original to the FP. This will be invaluable as evidence for future actions if need be.

We only want our local community banks and officials to comply with the law. If they do not, we can only bring pressure by legal means, through legal channels. Financial loss is a great way to get people to wake up. We want a community that is lawful, constitutional and just. If they don't want to be that way, then they can leave and go elsewhere. We don't want them here.

If we do not stand up against these deceptive and manipulating processes to steal our rights and freedoms, things will NEVER get better. If you are not **FOR** the constitution, Rule of Law, civil rights and freedoms, you are **against** them, and this makes YOU the “enemy combatant” and “domestic terrorist,” not to mention, **TRAITOR.**”

Taking back our county includes taking back our freedoms, and standing on our rights. County by county, American's can be acting by learning the simple laws, and how to stand on them, and placing pressure on those that would deny us our freedoms and our rights. “Change” can ONLY come when people unite and demand the law to be exercised lawfully and justly. Are you ready for this?

If you have no liability for Federal "income" taxes, you have NO CDR "income" tax liability and therefore have no legal duty to fill out the CDR tax form. (Just check the Colorado Revised Statutes)

5. Working to make a wage and living is a right, not a privilege, and cannot be taxed.

"It could hardly be denied that a tax laid specifically on the exercise of those freedoms would be unconstitutional... A state [or federal government] may not impose a charge for the enjoyment of a right granted by the federal Constitution." - *Murdock v Pennsylvania*, 319 US 105, at 113; 480-487; 63 S Ct at 875; 87 L Ed at 1298 (1943).

"Citizens under our Constitution and laws mean free inhabitants ... Every citizen and freeman is endowed with certain rights and privileges to enjoy which no written law or statute is required. These are fundamental or natural rights, recognized among all free people ... That the right to... accept employment as a laborer for hire as a fundamental right is inherent in every free citizen, and is indisputable..." *United States v. Morris*, 125 F. Rept. 325, 331.

7. The IR Code is a mishmash of confusing code, and almost impossible to read and understand:

"Eight decades of amendments...to [the] code have produced a virtually impenetrable maze...The rules are unintelligible to most citizens...The rules are equally mysterious to many government employees who are charged with administering and enforcing the law." - Shirley Peterson, former IRS Commissioner, April 14, 1993 at Southern Methodist University.

ROBERT C. MCKEE v. COMMISSIONER OF INTERNAL REVENUE No. 04-74846 IRS No. 4036-03: The Tax Court held the IRS was not liable for their calculation blunders on the basis that the Tax Court, in its discretion, claimed the regulations written by the IRS and codes were so complex that the IRS could not be held liable for its failure to understand them. On December 4, 2006, the 9th Circuit reversed the United States Tax Court. The Commissioner of the Internal Revenue asked the 9th Circuit not to make the decision public.

"A statute must be set out in terms that the ordinary person exercising ordinary common sense can sufficiently understand and comply with, without sacrifice to the public interest." See *Arnett v. Kennedy*, 416 U.S. 134, 159, 40 L. Ed. 2d 15, 94 S. Ct. 1633 (1974) (quoting *United States Civil Serv. Commission v. National Association of Letter Carriers*, 413 U.S. 548, 579, 37 L. Ed. 2d 796, 93 S. Ct. 2880 (1973)).

8. You are not a "taxpayer" until legally made one, or you voluntarily make yourself one:

"The revenue laws are a code or system in regulation of tax assessment and collection. They relate to taxpayers and not to non taxpayers. The latter are without their scope. No procedure is prescribed for non-taxpayers and no attempt is made to annul any of their rights and remedies in due course of law. With them Congress does not assume to deal, and they are neither of the subject nor of the object of the revenue laws. Persons

who are not taxpayers are not within the system and can obtain no benefit by following the procedures prescribed for taxpayers... The distinction between persons and things within the scope of the revenue laws and those without is vital." *Long v. Rasmussen*, 281 F. 236 (1922) stated at 238: (Referenced in *United States Court of Claims, Economy Plumbing and Heating v. United States*, 470 Fwd 585, at 589 (1972)).

The above is just the tip of the iceberg. Below is a discussion of some elements of the code, used with permission. Keep in mind that this subject has been distorted, obfuscated, purposefully made confusing on the outward appearance, but the truth and laws are simple once you see through the facade of lies and know what the code and laws are actually saying, and to whom.

As with many other topics coming in the FP, it will take some time to soak in... the learning curve... but it will free you from oppression, theft of your money and give us all that "bailout" we all deserve.

Deceptive IRS Code Words "Income," "Person," "Taxpayer," "Shall," and "Must."

The Internal Revenue Code (IRC) is a masterpiece of deception designed to mislead Citizens into believing that individuals are subject to federal income tax. The Code was written by attorneys for the Internal Revenue Service (IRS), and contains a series of directory statutes using the word "shall," with provisions that are requirements for corporations, but not for individuals. Even members of Congress are generally unaware of the deceptive legal meanings of certain terms that are consistently used in the IRC. These terms have legal definitions for use in the IRC that are very different from the general understanding of the meaning of the words.

Lack of knowledge of these legal definitions causes misunderstanding by uninformed Citizens who are confused as to the correct interpretation of both the IRC and the true meaning of the tricky wording in IRS instructional publications and news articles. However, when you understand the legal definitions of these terms, the deception is easily recognized and the limited application of the Code becomes clear. This understanding will help you to see that filing income tax forms and paying income taxes must be voluntary acts for most Americans because the United States Constitution forbids the federal government to impose any tax directly upon individuals.

INCOME

Most people mistakenly believe all moneys they receive, such as wages, salaries, and tips, are "income." However, for years, IRS publication #525, entitled "Taxable and Nontaxable Income," has acknowledged that wages and salaries are not "income." Publication #525 states: "Wages and salaries are the main source of income for most people." (Notice it states "source of income," and NOT that they are "income" themselves. This is key to understanding the fraud).

In the court decision of *Graves vs People of the State of New York ex rel O'Keefe*, 59 S.Ct. 595 (1939), the United States Supreme Court ruled that a source of income is not income, and the source is not subject to income tax. In that decision, the Court stated: "A tax on income is not economically or legally a tax on its source." However, wages, salaries, commissions, and tips (sources) are considered to be "income" for an individual when he lists them as "income" on an IRS tax return form. When he signs the tax form under penalty of perjury, he has made a voluntary oath that his wages, salary, commissions, and tips listed on the return are "income" and that he is subject to the tax.

In the still standing decision of *Brushaber vs Union Pacific Railroad Company*, 240 U.S. 1, the United States Supreme Court ruled that the federal income tax is an excise tax under the Sixteenth Amendment (the income tax amendment which was never legally ratified... <http://www.thematrixhasyou.org/affidavit-updated/attachment-aa-u.html>, <http://www.thematrixhasyou.org/affidavit-updated/attachment-y-u.html>).

The Court explained that the income tax cannot be imposed as a direct tax (a tax on individuals or on property) because the United States Constitution still requires that all direct taxes must be apportioned among the States. "Apportioned" means that a direct tax is laid upon the State governments in proportion to each State's population. The Court ruled that income tax can be constitutional only as an indirect (excise) tax -- that is, a tax on profits earned by corporations or privileges granted by government. In other words, said the Supreme Court, in order for there to be "income," there must be profits or gains received in the exercise of a privilege granted by government. As an example, a lawyer is granted the government privilege of being an officer of the government court when he represents clients in litigation.

At law, labor is property. In fact, the Supreme Court has identified labor as man's most precious property. Therefore, the exchange of someone's labor for wages or salary (which are also property) is considered by law to be an exchange of properties of equal value in which there is no gain or profit. Such a property exchange of equal value cannot be taxed because there is no profit or gain. (Please see <http://www.thematrixhasyou.org/PDF/what-is-income.pdf> for detailed explanation on this). Also, one who works in an ordinary occupation is not a recipient of any privilege granted by government, because he is merely exercising his constitutionally guaranteed right to work and earn a living. Courts have repeatedly ruled that no tax may be placed upon the exercise of rights. Their reasoning was sensible. If the exercise of rights could be taxed, government could destroy them by excessive rates of taxation.

Items that the law includes in "income" are described in Code sections listed under the title of "Items Specifically Included in Gross Income," which covers Sections 71 through 86. Nowhere in these sections and nowhere else in the Code is there any mention of wages, salaries,

commissions, or tips as being "income." For example, to deceive and intimidate waitresses into declaring their tips to be income is a double fraud. First, tips are gifts, not wages. According to the IRC, gifts are not subject to income tax. In fact, even if tips were considered to be wages, they would still not be "income" and would not be subject to an income (excise) tax unless one enters them as "income" on a tax return form.

PERSON

People generally consider the term "person" to mean an individual only. But, IRC Section 7701, entitled "Definitions," includes a corporation, a trust, an estate, a partnership, an association, or company as being a "person." All of these legal entities are "persons" at law, so it is legally correct but very misleading when the federal income (excise) tax on corporations is described by the deceptive title of "Personal Income Tax." This misleading description leads most people to believe that it means a tax on individuals.

The legal term "person" has an even more restricted definition when used in IRC Chapter 75, which contains all the criminal penalties in the Code. In Section 7343 of that Chapter, a "person" subject to criminal penalties is defined as:

"... [A]n officer or employee of a corporation, or a member or employee of a partnership, who, as such officer, employee or member, is under a duty to perform the act in respect of which the violation occurs."

An individual who is not in such a capacity is not defined as a "person" subject to criminal penalties. Unprivileged individuals, who do not impose the income (excise) tax upon themselves by filing returns, are not subject to the tax and they are not "persons" who can lawfully be subjected to criminal charges for not filing a return or not paying income tax.

Sections of the Code relating to the requirements for filing returns, keeping records, and disclosing information state that those sections apply to "every person liable" or "any person made liable." These descriptions mean "any person who is liable for the tax." They do not state or mean that all persons are liable. The only persons liable are those "persons" (legal entities such as corporations) who owe an income (excise) tax, and are therefore subject to the requirements of the IRC. If you substitute the word "corporation" for the term "person" (a corporation is a person at law) when reading the Code or other articles and publications relating to income tax, the true meaning of the Code becomes more apparent.

A "TAX PAYER" IS NOT A "TAXPAYER"

The deceptive term "taxpayer" is a legal term created by combining the words "tax" and "payer." The general understanding of the term's meaning is different from its legal definition in the IRC.

Section 7701(a)(14) gives the legal definition of the term "taxpayer" in relation to income tax. It states: "The term 'taxpayer' means any person subject to any internal revenue tax." (All internal revenue taxes are excise taxes.) Note that the section does not say that all persons are "taxpayers" subject to internal revenue tax.

Corporations are "taxpayers," for they are "persons" subject to an internal revenue (excise) tax.

The term "taxpayer" is used extensively throughout the IRC, in IRS publications, news articles, and instructional literature as a verbal trap to make uninformed Citizens believe that all individuals are subject to federal income tax and to the requirements of the IRC.

These materials state that "taxpayers" are required to file returns, keep records, supply information, etc. Such statements are technically correct, because "taxpayers" are those legal "persons" previously described that are subject to an excise tax, but unprivileged individuals are not "taxpayers" within the meaning of the IRC.

The confusion about the meaning of the term leads most people to mistakenly assume that they are "taxpayers" because they pay other taxes such as sales taxes and real estate taxes. Those people are tax payers, not "taxpayers" as defined in the IRC. When they read articles and publications related to income tax, describing the legal requirements for "taxpayers," they erroneously believe that the term applies to them as individuals.

It is very important to understand that the IRC requirements apply to IRC-defined "taxpayers" only, and not to unprivileged individuals. Corporations and other government-privileged legal entities are "taxpayers under the Internal Revenue Code;" unprivileged individuals are not, unless they voluntarily file income tax returns showing they owe taxes, thus legally placing themselves in the classification of "taxpayers."

Because of its legal definition, the term "taxpayer" should never be used in relation to income tax, except to describe those legal entities subject to a federal excise tax.

"SHALL" means "MAY"

In general use, the word "shall" is a word of command with a mandatory meaning. In the IRC, "shall" is a directory word that has a mandatory meaning when applied to corporations. The IRC contains a series of directory statutes using the word "shall" in describing the actions called for in those sections of the law.

The provisions of these directory statutes are requirements for corporations, because corporations are created by government and, consequently, are subject to government direction and control. Since corporations are granted the privilege to exist and operate by government-issued charters, they do not have the constitutionally guaranteed rights of individuals.

This government-granted privilege legally obligates corporations to make a "return" of profits and gains earned in the exercise of their privileged operations when directed to do so by law. This is why the tax form is called a "return."

However, directory words in the Code merely imply that individuals are required to perform certain acts, but directory words are not requirements for individuals when a mandatory interpretation of the directory words would conflict with the constitutionally guaranteed rights of individuals. Courts have repeatedly ruled that in statutes, when a

mandatory meaning of the word "shall" would create a constitutional conflict, "shall" must be defined as meaning "may." The following are quotes from a few of these decisions. In the decision of Cairo & Fulton R.R. Co. vs Hecht, 95 U.S. 170, the U.S. Supreme Court stated:

"As against the government the word "shall" when used in statutes, is to be construed as "may," unless a contrary intention is manifest."

In the decision of George Williams College vs Village of Williams Bay, 7 N.W.2d 891, the Supreme Court of Wisconsin stated:

"Shall" in a statute may be construed to mean "may" in order to avoid constitutional doubt."

In the decision of Gow vs Consolidated Coppermines Corp., 165 Atlantic 136, the court stated:

"If necessary to avoid unconstitutionality of a statute, 'shall' will be deemed equivalent to 'may'

Sections 6001 and 6011 of the IRC are cited in the Privacy Act notice in the IRS 1040 instruction booklet in order to lead individuals to believe they are required to perform services for tax collectors. Note the use of the word "shall" in the following sections of the Code:

Section 6001 states:

Every person liable for any tax imposed by this title, or for the collection thereof, shall keep such records, render such statements, make such returns, and comply with such rules and requirements as the Secretary may from time to time prescribe.

Section 6011 states:

When required by regulations prescribed by the Secretary any person made liable for any tax imposed by this title, or for the collection thereof, shall make a return or statement according to the forms and regulations prescribed by the Secretary.

Note that Sections 6001 and 6011 apply to "every person liable" and "any person made liable," but not to "individuals." However, there is no section of the IRC that makes individuals liable for payment of income tax because any law imposing a federal tax on individuals would be unconstitutional, for it would violate the taxing limitations in the U.S. Constitution which prohibit direct taxation of individuals by the federal government. People are often confused when reading the Code because, under Subtitle A, Chapter 1, which covers income taxes, Part 1 of Subchapter A has the misleading title of "Tax on

Individuals." The title is misleading because Part 1 imposes the tax on "income," but contains no requirement for individuals to pay it.

But an individual becomes a "person liable" for the tax when he files an income tax form, thereby swearing that he is liable for (owes) the tax.

The Privacy Act notice in the instruction booklet for IRS Form 1040 also shows that disclosure of information by individuals is not required. The notice states:

Our legal right to ask for information is Internal Revenue Code sections 6001 and 6011 and their regulations.

The IRS does not say that those sections require individuals to submit the information; those sections only

give the IRS the authority to ask for it.

Section 6012 states:

Returns with respect to income taxes under Subtitle A shall be made by the following: (1)(A) Every individual having for the taxable year gross income which equals or exceeds the exemption amount"

Subsections (2) through (6) list corporations, estates, trusts, partnerships, and certain political organizations as also being subject to this section.

Any requirements compelling unprivileged individuals to keep records, make returns and statements, or to involuntarily perform any other services for tax collectors, would be violations of constitutionally guaranteed rights.

The Thirteenth Amendment to the United States Constitution forbids compelling individuals to perform services involuntarily. The Amendment states:

"Neither slavery nor involuntary servitude, except as punishment for crimes whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction.

The Fourth Amendment in the Bill of Rights of the United States Constitution states that the people's right to privacy of their papers shall not be violated by government. To compel individuals to disclose information taken from their papers would violate this right.

The Fifth Amendment in the Bill of Rights protects the right of individuals not to be required to be witnesses against themselves. To compel individuals to disclose information by submitting statements or information on a tax return form, all of which could be used against them in criminal prosecutions, would violate their Fifth Amendment right.

These examples show some constitutional conflicts that would result from defining the word "shall" as meaning "is required to." Thus, "shall" in the above mentioned statutes must be interpreted as meaning "may." Consequently, for individuals, keeping records, making statements, and making returns are clearly voluntary actions that are not required by law.

"HAVING" INCOME

According to the wording of Section 6012 previously discussed, it is a directory statute which pertains to the filing of income tax returns, and applies only to those individuals "having income." Since the word "having" has no deceptive legal definition in the Code, its legal meaning is the same as its customary meaning in general use. Although dictionaries define the word "have" as meaning "possess" or "hold in someone's possession," the IRS fraudulently misinterprets "having income" as meaning "receiving gross receipts" when applying Section 6012 to individuals.

To better understand the meaning of "having income," consider this example: If during one year a corporation receives ten million dollars (gross receipts) from the sales of its products, and has expense items of nine million dollars, the corporation has a profit (income) of one million dollars. When tax liabilities are determined at the end of the year, the corporation has (possesses) an increase in its assets (a

gain) of one million dollars. But, if the corporation's expenses equalled its gross receipts, it would then have (possess) no profit or gain (income) and it would owe no income tax.

Now, consider another example: If during one year an individual receives fifteen thousand dollars in wages (gross receipts) from the sale of his labor, and has expenses of fifteen thousand dollars to sustain himself and his family, he then has (possesses) no increase in assets. Although he has (possesses) nothing more than he had at the beginning of the year, IRS agents consider him as "having income" of fifteen thousand dollars. IRS agents ignore the fact that his wages were not income according to their own publications!

"MUST" means "MAY"

Most people have never studied the IRC and their understanding of the law is generally based on hearsay, newspaper articles and IRS instructional materials. These instructions make frequent use of the deceptive word "must" in describing the things that the IRS wants you to do, because "must" is a forceful word that people mistakenly believe to mean "are required." Very few people realize that "must" is a directory word similar to "shall" and that, in IRS instructions to the public, it means "may," the same as the word "shall."

In the legal definition of the word "must" in Black's Law Dictionary, it states:

... [I]t is often used in a merely directory sense, and consequently is a synonym for the word "may" not only in the permissive sense of that word, but also in the mandatory sense which it sometimes has.

Because of the constitutional conflicts explained earlier in this article, the word "must," similar to the word "shall," cannot have a mandatory meaning for individuals. It therefore means "may" when used in IRS instruction publications.

The IRS instructions for Form 1040 state that you "must" file a return if you have certain amounts of income. IRS withholding instructions state that employers "must" withhold money from paychecks for income tax, "must" withhold social security tax (an income tax also), and "must" send to the IRS any W-4 withholding statement claiming exemption from withholding, if the wages are expected to usually exceed \$200 per week. An understanding of the legal meaning of the word "must" exposes the deception by the IRS and makes it clear that the actions called for are voluntary actions for individuals that are not required by law. If these actions were required by law, the instructions would not use the word "must," but would say that the actions were "required."

FREE SOVEREIGN CITIZENS

Prior to the American Revolution, the American colonists were subjects of the English Kings and were subject to their orders and edicts. But, according to the Declaration of Independence and the United States Constitution, the Citizens of our country are free sovereign individuals. They are not subjects of government, nor are they subject to mandatory direction or control by the federal government. Except for duties such as military draft and jury duty, the federal government has no authority

Jury Duty Rights and American's Responsibility to Safeguard Freedoms!

Did you know that you qualify for another, much more powerful vote than the one which you cast on election day? This opportunity comes when you are selected for jury duty, a position of honor for over 700 years.

But does the jury's power to veto bad laws exist under our Constitution?

It certainly does! At the time the Constitution was written, the definition of the term "jury" referred to a group of citizens empowered to judge both the law and the evidence in the case before it. Then, in the February term of 1794, the Supreme Court conducted a jury trial in the case of the State of Georgia vs. Brailsford (3 Dall 1). The instructions to the jury in the first jury trial before the Supreme Court of the United States illustrate the true power of the jury. Chief Justice John Jay said: "It is presumed, that juries are the best judges of facts; it is, on the other hand, presumed that courts are the best judges of law. But still both objects are within your power of decision." (emphasis added) "...you have a right to take it upon yourselves

to judge of both, and to determine the law as well as the fact in controversy."

So you see, in an American courtroom there are in a sense twelve judges in attendance, not just one. And they are there with the power to review the "law" as well as the "facts"! Actually, the "judge" is there to conduct the proceedings in an orderly fashion and maintain the safety of all parties involved.

As recently as 1972, the U.S. Court of Appeals for the District of Columbia said that the jury has an "unreviewable and irreversible power... to acquit in disregard of the instructions on the law given by the trial judge.... (US vs Dougherty, 473 F 2d 1113, 1139 (1972)).

Or as this same truth was stated in a earlier decision by the United States Court of Appeals for the District of Maryland: "We recognize, as appellants urge, the undisputed power of the jury to acquit, even if its verdict is contrary to the law as given by the judge, and contrary to the evidence. This is a power that must exist as long as we adhere to the general verdict in criminal cases, for the courts cannot search the minds of the jurors to find the basis upon which they judge. If

the jury feels that the law under which the defendant is accused, is unjust, or that exigent circumstances justified the actions of the accused, or for any reason which appeals to their logic of passion, the jury has the power to acquit, and the courts must abide by that decision." (US vs Moylan, 417 F 2d 1002, 1006 (1969)).

YOU, as a juror armed with the knowledge of the purpose of a jury trial, and the knowledge of what your Rights, powers, and duties really are, can with your single vote of not guilty nullify or invalidate any law involved in that case. Because a jury's guilty decision must be unanimous, it takes only one vote to effectively nullify a bad "act of the legislature." Your one vote can "hang" a jury; and although it won't be an acquittal, at least the defendant will not be convicted of violating an unjust or unconstitutional law.

The government cannot deprive anyone of "Liberty," without your consent!

Jurors Must Know Their Rights:

You must know your rights! Because, once selected for jury duty, nobody will inform you of your power to judge both law and fact. In fact, the

judge's instructions to the jury may be to the contrary. Another quote from US vs Dougherty (cited earlier): "The fact that there is widespread existence of the jury's prerogative, and approval of its existence as a necessary counter to case-hardened judges and arbitrary prosecutors, does not establish as an imperative that the jury must be informed by the judge of that power."

You've been informed... so apply truth, justice, and conscience as you do your jury duty.

"I consider trial by jury as the only anchor yet imagined by man by which a government can be held to the principles of its constitution."

Don't be deceived by lying court judges and others with vested interest in manipulating your conscience and truth. You have the RIGHT to vote your conscience, and to uphold the constitution and Rule of Law that is often ignored by courts.

SHERIFF'S ONLY DUTY: Protect and Defend the People and their Property

County Sheriffs are supposed to be the protectors of the people in the county. They are to protect the people from all criminal activity – criminal activity in the streets of the county and criminal or damaging activity from state or federal governments. Most sheriffs are well aware of the first part of their jurisdiction and protective duties, but sadly, not the second part.

When the federal Brady Bill came out and we county sheriffs were told by the federal government that we would be required to enforce this anti-Second Amendment legislation on the people of our counties, I challenge it as unconstitutional – all the way to the U.S. Supreme Court. (Mack v. Brady) We won our suit against the federal government, on behalf of all sheriffs in America. The U.S. Supreme Court told us what we already knew: that no sheriff is obligated to act as an agent for, and do the work of, the federal government. We would not have to enforce the Brady Bill on behalf

of the federal government! This case proved again, that if the people and their elected officials [sheriffs and other local/county officials] will stand up together, we can win against the many unconstitutional actions and unlawful jurisdictional usurpations of the federal government.

So, does the federal government currently control your county office of sheriff? This is certainly a question that deserves to be weighed. We ask it again: Does the federal government have the constitutional authority or lawful jurisdiction to tell a county sheriff what to do? Absolutely not! The only way that the federal government has any control over the county sheriff is if the sheriff, for some reason, acquiesces and goes along, allowing federal agents and their agencies to take control.

One thing we sheriffs definitely need to realize, however, is this: One of the surest ways we can begin to lose our local authority and independence, and pave the way for the federal government to begin to exercise control within our counties, is through our acceptance of federal funds such as the form of grants, or even "surplus" law enforcement equipment, etc. We must remember that truly there is no

free money from the federal government: it all comes "with strings attached." Insist on remaining an independent servant of the people: Do not accept the funds.

The following may shock many of my fellow sheriffs, but let's look at the law. According to the Supreme Law of our Land, the U.S. Constitution, there are only three areas in which the federal government is lawfully allowed to involve itself in the law enforcement. Article I, Section 8 of the U.S. Constitution lists these as: One, felonies committed on the high seas; Two, counterfeiting; and Three, Treason. Constitutionally, these three crimes alone allow the federal government to assume jurisdiction and take control. They have no other lawful powers!

So why do we so often allow unlawful incursions by federal agents into our counties? Answer: FIRST because we haven't really known the Supreme Law, and SECOND because, as county officials, we have all-too-willingly put our lips around the federal "sugar teat," taking [collectively] millions upon millions in federal handouts. And of course, once we've done this, we are then obligated to obey what the feds tell us – especially if we should be

looking to obtain still more "sugar" next year!

Does this sound like the highest and best we can expect from ourselves as the elected, trusted guardians of the rights and liberties of the local citizens we are sworn to serve?

The Social Security Ponzi Scheme.

In the past several months as the debate over Social Security reform has taken center stage in the theater of the absurd that is modern American politics, the idea has been floated that the entire pay—as—you—go structure of this system closely resembles a Ponzi scheme, albeit one that is about to collapse.

In reality, few people likely have any idea what a Ponzi scheme is, nor how closely America's largest retirement system follows its outlines. According to the Securities and Exchange Commission:

'Ponzi schemes are a type of illegal pyramid scheme named for Charles Ponzi, who duped thousands of New England residents into investing in a postage stamp speculation scheme back in the 1920s. Ponzi thought he could take advantage of differences between U.S. and foreign currencies used to buy and sell international mail coupons. Ponzi told investors that he could provide a 40% return in just 90 days compared with 5% for bank savings accounts. Ponzi was deluged with funds from investors, taking in \$1 million during one three-hour period—and this was

1921! Though a few early investors were paid off to make the scheme look legitimate, an investigation found that Ponzi had only purchased about \$30 worth of the international mail coupons. Decades later, the Ponzi scheme continues to work on the "rob—Peter—to—pay—Paul" principle, as money from new investors is used to pay off earlier investors until the whole scheme collapses.'

Sound eerily familiar? Much as in the original Ponzi scheme, Social Security also paid huge returns to its first investors who, whether intentionally or not, led Americans to believe the plan worked marvelously, thereby engendering the support of an exceedingly grateful nation.

For instance, the first American to ever receive a check from this new national savings plan was Ernest Ackerman, a streetcar motorman from Cleveland, Ohio who retired exactly one day after the program went into effect. For the five cents that was deducted from Mr. Ackerman's check the sole day he was a 'participant', he received a lump—sum payment of 17 cents. This was a 240% return, which annualizes out to 87,600%. Nice investing, Ernie.

Then, in 1939, a series of changes were made to this new retirement system that included moving up the start of monthly payments by two years. As a

result, the first monthly Social Security check went out on January 31, 1940 to Ida May Fuller, a retired legal secretary from Ludlow, Vermont.

This maiden disbursement was \$22.54, which, according to Social Security Online, after cost of living increases and 35 years of receipts until her death in 1975, totaled a startling \$22,888.92 in payments from a system to which Mrs. Fuller contributed \$24.75.

Now, please bear in mind that Mr. Ponzi was only promising people a 40% return on their money in 90 days. By contrast, the first Social Security recipients received yields approaching 100,000 percent.

Unfortunately, few participants in a Ponzi scheme ever achieve such spectacular returns, and the whole scam invariably implodes when the real investors have the nerve to ask for their money back. For instance, when regulators finally shut Mr. Ponzi's operation down in 1920, they were only able to recover \$1.593 million. Sadly, this was a small pittance compared to the \$15 million he owed his 40,000 investors, not including the interest he had promised them.

This makes it quite logical that 70 years after our government implemented a Ponzi scheme of its own — remarkably just fifteen years after the first one imploded — the real investors (a.k.a., the

baby boomers who have paid into this program since they received their first pay checks, while absorbing numerous increases to the required contributions) are concerned that there won't be enough money available to fund their own retirements.

Naturally, irrespective of the protestations of those who seem able to attain high office in our nation without possessing even the most rudimentary arithmetic acumen, these fears are warranted. Yet, now that the flaws in this equation have finally been exposed, the debate is unconscionably focused on the machinations of extending this scheme rather than if and how we should unwind it.

After all, as the best returns from this plan have already been realized by folks like Mrs. Fuller and Mr. Ackerman — as well as millions of seniors in the past seventy years who received yields on their contributions that can't possibly be replicated — shouldn't the rest of us who can add one plus one without difficulty be entitled to opt out of this investment nightmare?

Such a question becomes even more appropriate considering the gags yet to be played in this inhumane comedy in the form of neatly disguised — yet predictable — Democratic

to require unprivileged individuals to perform services for government.

There is no section in the IRC requiring individuals to pay income tax or file income tax returns, because the federal government has no constitutional authority to impose any tax directly upon individuals or to require them involuntarily to keep records, make statements, make returns, or perform any acts for the convenience of federal tax collectors. But, if an individual files a return, his voluntary action of signing the form, thereby swearing under penalty of perjury that he owes the tax, is an acknowledgement under oath that he is subject to the tax (a "taxpayer") and is therefore subject to the directory statutes of the IRC.

The reader should remember the legal definitions of the various terms and the information about the rights of Citizens presented in this article whenever he reads the IRC and other materials relating to income tax in order to better understand the correct meaning of whatever they read. (End)

Billions of dollars were recently lost in the collapse of Bernie Madoff's self-described Ponzi scheme, in which too-good-to-be-true returns on investments were not really returns at all, but the funds of defrauded new investors. The pyramid scheme collapsed dramatically when too many clients called in their accounts, and not enough new victims could be found to support these withdrawals. Bernie Madoff was running a blatant fraud operation.

Fraud is already illegal, and he will be facing criminal consequences, which is as it should be, and should act as an appropriate deterrent to potential future criminals. But it seems every time someone breaks the law, politicians and pundits decide we need more laws, even though lack of laws was not the problem.

The government itself runs a fraud much bigger than Madoff's. Our Social Security system is the very definition of a Ponzi, or pyramid scheme. If the government truly had an interest in protecting people's savings, they would allow people to opt out of Social Security altogether. We would cut wasteful spending, such as our overseas empire, to honor current obligations to seniors, and eventually phase the program out. Instead, as with Enron and Sarbanes Oxley, I expect new, unrelated legislation to be proposed that further damages freedom in the name of protecting us, amidst loud proclamations that they have made the world safe.

Merely passing a law does not fix any problems, just as throwing paper at a recession does not stop it. How can a government so complicit in mandatory public fraud effectively pre-empt private fraud? I see no reason to believe that any new law, or regulatory agency will solve anything. But I do see liberty slipping away every time Congress decides to "do something." We already have an oversight agency, the SEC, which did a poor job overseeing and preventing this, but does a great job hamstringing honest, productive businesses and driving them overseas.

Total trust in government solutions only creates moral hazard, and amplifies risky behavior. Trust in government got us here. We trusted government to eliminate risk, but it just made risk more creative and dangerous. We trusted the Federal Reserve, a supra-governmental cabal of private banks, to know better than the free market what interest rates should be, and how to stabilize the business cycle, but like a spinning top that loses its balance, it has instead spun the business cycle and the economy wildly out of control.

No governmental activity can negate market forces or nullify the

cardinal rule of caveat emptor. Government can however, use our fears against us and promise unrealistic outcomes as a means to consolidate power and erode our liberties. Liberty comes with risk. This is a fact of life. But life without liberty is not much of a life at all.

The only way the American people will get through these difficult times is through our own resilience and ingenuity. At best, the government is irrelevant in finding prosperity again. At worst, government can present a massive obstacle for the economy to overcome. If we do not wise up and rein government back in to its Constitutional limitations, bloated government could be a cumbersome unnecessary weight the economy will continually have to support to stay afloat.

Now, in 2008, tyranny and government excesses are again upon America , but this time it is by America 's own hand. The policies of King George III were no more egregious than the policies of

President George Bush II.— taxation without real representation, e.g. TARP (80 % Americans opposed), the imposition of policies contrary to the will of the people, e.g. US presence in Iraq and Afghanistan (70 % opposed), and the loss of individual freedoms under the Patriot Act (60 % opposed).

The difference between 1776 and 2008 is that America is now tyrannized not by the King of England but by its own government. Today, the US government does not represent the will of the people. It represents instead the special interests that control the US government through the buying of votes— America is not for sale only because it has already been sold.

The difference between 1776 and 2008 is not only 232 years. It is the difference between the dream of the Founding Fathers and the shadow of that dream in whose increasing darkness Americans now exist.

THE FEDERAL RESERVE BANK IS THE REASON FOR AMERICA 'S FALL FROM POWER AND THE SOURCE OF ITS INCREASING PROBLEMS

Thomas Jefferson warned 200 hundred years ago that if private bankers were allowed to issue America 's money, indebtedness, foreclosure and suffering would follow. Yet, in 1913, private bankers gained control over America 's money by the passage of the Federal Reserve Act.

We are now suffering for ignoring Jefferson 's warnings. Jefferson was right in predicting our problems but his words were overridden by those who had other plans for America , plans that would increase their profits at the expense of the nation.

It is no accident America is now an empty shell of the great economic power it once was. Bled dry by debt imposed by those whose sole intent was to profit, the US is now bankrupt at a time it desperately needs the resources it no longer has.

The problem is that too many don't know the laws, and too many fear standing up for what is right against powerful corruption. Is there risk in defending truth and fighting evil? In the last two centuries, Americans have come to identify

more with England (perhaps a cultural variant of the Stockhausen syndrome) than with its first ally, France—the lure of a good Burburrry overcoming its love for the great cloak of freedom. Unfortunately, Americans have forgotten their history and what they haven't forgotten they have now reinvented.

Freedom is always fragile and is always under attack from those who would enslave others for their own ends, including profit; and, the present crisis is as threatening to America as was the crisis of 1776.

New Element Discovered!

Lawrence Livermore Laboratories has discovered the heaviest element yet known to science. The new element, Governmentium (symbol=Gv), has one neutron, 25 assistant neutrons, 88 deputy neutrons, and 198 assistant deputy neutrons, giving it an atomic mass of 312. These 312 particles are held together by forces called morons, which are surrounded by vast quantities of lepton-like particles called peons. Since Governmentium has no electrons, it is inert. solutions to avert the imminent crisis they maintain is neither imminent nor a crisis. To date, these options comprise increasing the Social Security tax cap above its current \$90,000 threshold, and eliminating the 2003 tax cuts on the wealthiest wage earners.

As a result, no matter how you slice it, their 'solution' is to once again demand that people pay additional funds into this failing system above and beyond what was originally dictated by statute. 

Judy Wallman, a professional genealogy researcher in southern California, was doing some personal work on her own (Reid) family tree. She discovered that Harry Reid's (Senate Majority Leader) great-great uncle, Remus Reid, was hanged for horse stealing and train robbery in Montana in 1889. Both Judy and Harry Reid share this common ancestor.

The only known photograph of Remus shows him standing on the gallows in Montana territory.



On the back of the picture Judy obtained during her research is this inscription: 'Remus Reid, horse thief, sent to Montana Territorial Prison 1885, escaped 1887, robbed the Montana Flyer six times. Caught by Pinkerton detectives, convicted and hanged in 1889.'

So Judy recently e-mailed Congressman Harry Reid for information about their great-great uncle.

Believe it or not, Harry Reid's staff sent back the following biographical sketch for her genealogy research:

'Remus Reid was a famous cowboy in the Montana Territory. His business empire grew to include acquisition of valuable equestrian assets and intimate dealings with the Montana railroad. Beginning in 1883, he devoted several years of his life to government service, finally taking leave to resume his dealings with the railroad. In 1887, he was a key player in a vital investigation run by the renowned Pinkerton Detective Agency. In 1889, Remus passed away during an important civic function held in his honor when the platform upon which he was standing collapsed.'

Back to the Weimar Republic

A wise man once said, "those who don't learn from history are doomed to repeat it." CNN's Glen Beck recently stated he received a call from a "highly placed" friend who said: "Everybody I know, Glenn, is reading a book about the Weimar Republic". Beck then posed the question, "Who is reading them all, and why now?"

A quick scan of German history reveals a tremendous amount of what happens when a nation injects liquidity into the market to cover bad loans or pay off institutions. Upon examining the Weimar Republic's playbook, frightening parallels begin to emerge between American economic solutions and 1920's Germany. It is encouraging to note that "highly placed" individuals are learning about the Weimar Republic, but are they learning to reroute us from the Weimar destiny or drive us into it?

Born out of World War 1, the Weimar Republic, as it would come to be known, experienced rates of inflation resulting in loafs of bread purchased with buckets of money and cash burned to heat homes in place of firewood.

In 1923, the fledgling Republic defaulted on war reparations demanded by the Versailles treaty. Defaulting on the payments resulted in occupation by French and Belgium troops in the Ruhr region, the most productive industrial region of Germany at the time. The occupation led to general strikes lasting eight months. As a result of these strikes, no goods or services were produced causing lasting damage. The French, demanding payment for the reparations and receiving nothing because of the work stoppage, started a campaign to exile and murder workers participating in the strikes.

The German workers, who chose to strike, were financially supported

by the state. In order to meet the demands to support the workers, the German Government printed money to cover their debt. Without goods and services to trade, hyperinflation resulted from the injection of cash into the economy. War loans and reparations were paid with devalued German Marks. Wealthy industrialists, benefiting from the increased supply of money in the market, were then able to pay back their loans. As more and more money was injected to cover loans, war debt, and striking workers, Germans awoke to find their fiat currency rendered worthless.

According to Wikipedia¹, the open source collaborative encyclopedia, "The value of the Papiermark had declined from 4.2 per US dollar at the outbreak of World War I to 1 million per dollar by August 1923. On 15 November 1923, a new currency, the Rentenmark, was introduced at the rate of 1 trillion (1,000,000,000,000) Papiermark for 1 Rentenmark. At that time, 1 U.S. dollar was equal to 4.2 Rentenmark."^[1]

After the rampant inflation, Germany's only solution to stabilize the currency was to introduce the Rentenmark. Fast forward to present day. Let's examine what is taking place in our market. We may not have a threat of French and Belgium troops knocking at our door, but we do have media and government officials telling us there is a terrorist under every bed. Do we have the threat of work stoppages and general strikes? No, but we do have a very real situation regarding the production of goods. The adoption of NAFTA and "free trade" agreements drastically reduced domestic production of goods, creating a massive trade deficit. American workers, now jobless as a result, find themselves in the unemployment line waiting for their government check, just like the striking German workers supported with the inflated German Mark. Defaulted loans from the sub-prime mortgage meltdown caused a chain reaction which shattered the foundations of some of the most respected insurance and banking institutions in the world.

The mortgage meltdown is a direct result of 1) failed Federal Reserve policies, 2) corrupt lending practices, and 3) bundled loans sold to the now failed banks. Without legislative oversight, the FED pumped billions of dollars in cash into the market to increase liquidity and boost confidence. Within days after the cash injection, Wall Street requested, another round of billions of dollars with added sweeteners to

1 year of food in their pantries, even those without farms. It was common sense back then.

What can anyone of us do about such a huge problem today? Ask yourself some questions; If I don't have money, food, water, or shelter, or all the above, what can I do? (See Wednesday, September 3, 2008 issue of FP, page 14, or eventually online at southwestfreepress.com, article titled "Forewarned is Forearmed!")

Since money is on everyone's mind, we should briefly discuss how to prepare to some degree for the coming collapse of the dollar. Unless a miracle occurs, normal American finances are a thing of the past. Since any so-called "money" is worthless, if it is not backed by something of value besides "confidence," it is critical to have real money... items of exchangeable value. What are such things?

AFTER... I repeat AFTER you have prepared with food, water, guns and ammo, etc., you can do one of several things: 1. Put your savings into International currencies, such as the Swiss Franc, or other currencies. I'm not real confident in the Euro, but this may do better than the dollar when the collapse comes. Remember, the collapse or demoralization of the U.S. dollar will impact the entire world economy, and most currencies in this world are fiat currencies... not backed by anything.

Silver and gold are the two best investments to make, in that order. Silver is poised to rise in value far better than gold, and here's why. There is more gold above ground than silver. Silver is an industrial metal, being consumed in business and industry on a daily basis.

Gold is mostly used in coins and jewelry. The jewelry doesn't get "consumed."

Some authorities, such as silver expert Theodore Butler, feel that silver has the potential to climb to as high as \$1000 per oz. Yes, that's One THOUSAND dollars an ounce. Why? Because of it's undervaluation, and it being kept artificially low due the commercial value. At some point, however, businesses and the public are going to wake up and realize the actual scarcity of silver, and you can bet mining will explode, along with the price of silver.

So, all you need to do is to obtain silver as traditional American coins, known as "junk silver," such as pre 1964 dimes, quarters and halves... 1963 and prior coins were largely silver, with a known value.

One can also obtain either silver dollars, known as eagles, (99% silver) (morgans, (app. 75%) eisenhower, (40%), etc. You can also get what are called "rounds" which are minted by reputable mints and have a known value, usually 99+% pure silver. These are all easily exchanged because of their known value, and of course, silver is accepted worldwide.

Gold is another possibility, but much harder to get in easily spendable quantities. There are many countries with these types of coins. American Eagles, Canadian Gold Maple Leaf, Austrian Philharmonic and South African Krugerrand to name a few.

Just be sure to work with a reputable company, and be sure to get the coins, "in hand." They will send them to you, under cover, and you can store them in any one of a thousands discrete places, usually NOT in your home, unless you have a "safe room," or very secure, hidden place. (I prefer way outside...) DO NOT STORE

ANYTHING OF VALUE IN A SAFE DEPOSIT BOX. In the event of martial law, or other crisis, you will likely either not be able to get to your box (banks closed) or lose everything in them due to "regulations," or even confiscation.

For what it is worth, we are likely entering a time that will try us all, short of a major breakthrough of sanity and lawfulness, and will either destroy us or bind us together into a mighty force that will defend, at all costs, liberty, freedom, family and neighbor.

I know of many in our county who have not only prepared with the essentials for life, but have "neighborhood teams" working together in preparation for possible tough times. If they don't come... great. We are all happy. If they DO come... only those who have taken the time and effort to do something will benefit.

It really does come down to the basics of courage, confidence, a community and American spirit, loving freedom, and discarding fear, apathy and skepticism. Of course, there will be many who do nothing and will expect others to take care of them, or worse, yet, be someone who will try to steal and pillage from others. THAT is why we need each other as the future approaches. I prefer having a great team at my side and not need them, much more than to have nothing and no one and need everything.

History has proven, over and over agin, that those who do nothing, and find themselves in a huge mess, are the ones who get hurt the worst... and it is impossible for those who have prepared to take care of everyone. THAT may be the hardest battle of all!

Does your bank protect your assets, or serve the State?

We will be assisting parties in various states who are preparing these suits and will use what evidence is available as part of these larger suits.

In the meantime, if you want to protect yourself and place your bank on legal notice, contact us and we can provide you a letter to do this very thing. Once noticed of the laws they are violating, they stand a poor chance of surviving any lawsuit brought against them, and could lose hundreds of times the amount taken.

Just another way to fight back using the laws as our tools!

protect the bankers and Paulson from liability. Seven hundred billion dollars was laid on the table of Congress for approval to bailout the bankers. Due to public outcry against the bill, the House defeated it, only to have it overturned by a second bill which was introduced to and passed by the Senate, then passed by the House, and signed into law. Peter Schiff, respected author of "Crash Proof" and president of the brokerage firm Euro Pacific Capital, reflected on the lead up to our current crisis during an October 13th exchange with Glen Beck [2], "credit comes from savings, and we blew through most of our savings when the dot-com bubble crashed, and then we started borrowing a lot of money from the rest of the world... We borrowed from China, Saudi Arabia, Russia and Japan, but now we can't pay the money back, and nobody wants to lend us anymore, so they're trying to recreate it with the printing press.

That's exactly what happened in Weimar Republic Germany, and that's exactly what's happening in Zimbabwe right now."

This exchange between Schiff and Beck was a remarkable admission on a major media network about the similarities of the US and 20's

Germany:

Peter Schiff: ...[R]emember the Weimar Republic, they were in trouble because of the reparations from the Treaty of Versailles, so they had huge external liabilities."

Glen Beck: [T]hey [Germany] got into a war and decided they didn't want to finance it with taxes or finance it with bonds. They just decided to run a deficit. That was the first step. PS: Right. That sounds very familiar, because that's what we're doing with Iraq. The thing is, we owe the world as much - if not more - than Germany owed, only we didn't [just] incur this debt fighting a war; we incurred it buying and remodeling our houses, and buying television sets and iPods and all these little gadgets we didn't really need. Now we owe the world trillions and we're reaching for the printing press to pay it back.

GB: And we're also reaching for a stimulus package which we have to go

For example, the basic theme in the movie is that the whole world people are living in is a computer generated illusion which they, in their growth tubes in some warehouse of human bodies, live out their lives and experiences, not realizing that the REAL world around them was a vastly different fact of reality.

Neo, (meaning "new") the main character of the movie, begins to suspect that something isn't right with things, and others who have escaped the matrix contact him to see if he wants to get out of the matrix and learn more about it. He is asked... "Do you want to see how far the rabbit hole goes?"

to the printing press to get back, too, and all these tax rebates and everything else.

PS: Of course all of it is coming from a printing press – there's no more money. We can't borrow it anymore from the rest of the world because we can't pay back the money we've already borrowed. What was the German solution to the inflation that plagued them? Create a new currency, and one already has been quietly created for North America. In 1999 the concept for a unified currency for Canada, Mexico, and the United States was presented by Canadian economist Herbert G. Grubel, in a book titled "The Case for the Amero". Shortly after, Dr. Robert A. Pastor, a member of the Council on Foreign Relations and co-chair of the 2005 CFR Independent Task Force on the Future of North America, introduced it as a monetary foundation for the three NAFTA countries.[3] The Fraser institute, publisher of "The Case for the Amero", speculates the Amero will be adopted on January 1, 2010.[4]

All that is needed to introduce the new currency is the total economic collapse we are witnessing right now. Distilling the problem to its source, the policies of the Federal Reserve have resulted in economic collapse so our nation could be brought under the authority of a regional if not global currency. The end of the Federal Reserve System may very well be on the horizon giving way to the North American Central Bank, envisioned by the Fraser Institute and functioning much like the European Central Bank.

The Council on Foreign Relations published an article, by Benn Steil, in its May/June 2007 issue of "Foreign Affairs" titled, "The End of National Currency"[5], which encouraged a global currency in the wake of a collapsing dollar.

Whether or not the pages of the Weimar Republic playbook are being reviewed, it is clear that think tanks and groups such as the Council on Foreign Relations and the Fraser Institute, will inevitably reach the conclusion that the answer to the currency crisis is a unified regional

Rep: Foreclosed owners should squat in their own homes.

If you're poor and the bank is coming for your home, Congresswoman Marcy Kaptur has a plan for you. Just squat, she says.

Yes, this Ohio Democrat is actually encouraging her financially distressed constituents whose homes have been foreclosed upon, to simply stay put.

In a Friday report, CNN's Drew Griffin explored the case of Ohioan Andrea Geiss, whose home was foreclosed upon in April.

"Behind in payments, out of work, a husband sick, she had nowhere to go," said Griffin. "So, she decided to follow the advice of her Congresswoman and go nowhere."

In Lucas County, Ohio, over 4,000 properties were foreclosed upon in 2008, reports CNN.

"So I say to the American people, you be squatters in your own homes," said Congresswoman Kaptur before the House of Representatives. "Don't you leave."

She's called on all of her foreclosed-upon constituents to stay in their homes and refuse to leave without "an attorney and a fight," said CNN.

"If they've had no legal representation of a high quality, I tell them stay in their homes," Kaptur

told Griffin.

Kaptur is a high-profile advocate of an increasingly popular mode of fighting foreclosures best known for it's key phrase: "Produce the note."

By telling a bank to "produce the note," a homeowner can delay foreclosure by forcing the lender to prove the suing institution is actually the same which owns the debt.

"During the lending boom, most mortgages were flipped and sold to another lender or servicer or sliced up and sold to investors as securitized packages on Wall Street," explains the Consumer Warning Network. "In the rush to turn these over as fast as possible to make the most money, many of the new lenders did not get the proper paperwork to show they own the note and mortgage. This is the key to the produce the note strategy."

And Friday's segment on this growing foreclosure fighting "movement" was not the network's first. Earlier in January, CNN explored one person's strategy in demanding her bank "produce the note," only to find that the lender had "lost or destroyed" the evidence of debt ownership. Such a revelation can significantly strengthen a homeowner's position when asking to renegotiate a mortgage.

That these banks, many of which received billions of dollars in government bailout funds, continue to boot defaulted owners from their

homes, makes them "vultures" says Kaptur.

"They prey on our property assets," she said. "I guess the reason I'm so adamant on this is because I know property law and its power to protect the individual homeowner. And I believe that 99.9 percent of our people have not had good legal representation in this."

Editor's Note: The issue of mortgage documentation is a huge deal. It is estimated that most mortgages that exist are based on **fraud...** in that the mortgage companies do NOT have the original, unaltered (no staple holes, and with the original signature,) documentation for your mortgage that proves they are the legal "Holders in Due Course" of the note and have right to your payment. This is a powerful tool to stop the loss of your home, and maybe keep it free of monthly payments!

CHAPTER 2 ARCHULETA COUNTY UPRISING—ROPE SECURED TO HANG ME...

Early in the spring of 1887 I was sent out on my first cowboy operation. In the southwestern part of Colorado on the border of New Mexico, was situated the County of Archuleta, the county seat being Pagosa Springs; and the nearest rail-road being Amargo, New Mexico.

What the Denver newspapers called anarchy, and a great uprising, had broken loose in this county which contained only about seventy-five voters. The residents of Archuleta county were mostly "Americans," but the Archuleta brothers of Amargo, New Mexico, ruled politically by flooding the county on election day with their New Mexican sheep herders who voted.

Finally the citizens rebelled and drove all the county officials with the exception of the sheriff and county clerk, who joined the insurgents, out of the country. They even burnt up some of their property and threatened death if they ever returned.

In order to retain their office by law, the five deported county commissioners, "Press" and "Don" Archuleta, Bendito Martinez, Mr. Scase and J. M. Archuleta, had to hold a county commissioners' meeting within sixty days; hence my being sent on ahead as a Texas outlaw, so as to be one of the revolutionists should a battle take place.

In Durango, Colorado, I bought a horse and saddle and rode sixty miles to Pagosa Springs. Enroute I stopped at the G. cattle ranch and made myself solid with Gordon G., who was one of the ringleaders of the up-rising and known as a "bad" man from Texas.

While at the G. ranch I confided in Gordon by telling him of how I had killed three Mexicans in Texas and had to skip. He also told me of trouble he had in Texas.

On reaching Pagosa Springs, I headed straight for the residence of E. M. Taylor, the County clerk, who was the brains and the leader of the evolutionists.

I had made up my mind to establish myself at the Taylor residence if nerve and gall could accomplish the feat.

Riding up to the porch I tied my horse and knocked on the front door. Mrs. Taylor appeared and informed me that her husband had gone to his sheep ranch, and would not be back till dark. I asked if I couldn't wait there until his return. She asked why I wished to see him. Told her that I wanted to

live with them awhile. Here the little lady climbed upon her dignity and informed me that they did not keep boarders; that there were two hotels in town. She then slammed the door in my face.

Recalling that old saying: "Faint heart ne'er won fair lady," I determined to try it. So unsaddling my pony and placing the saddle on the porch, I took the horse to the stable and gave him a good feed of grain and hay. Then returning to the porch, I lay down on the saddle.

It was a damp, cold day, and through the window I could see Mrs. Taylor and her only child, a ten-year-old daughter, sitting by the blazing fire in the hearth.

Through the window they could also see me. About dusk Mr. Taylor rode up on his horse and wanted to know what was up. I told him my tale of woe—that I had got into trouble in Texas and was hiding out—hence did not want to stop at a hotel. Also that I was a friend of Gordon G.'s. He replied that if I was a friend of Gordon's I could stop with them, providing he could get his wife's consent. He was absent in the house long enough to get the consent of ten men.

Mrs. Taylor was a splendid cook, and the warm supper hit the soft spot in my heart. And the nice clean bed in a cozy front room put me at peace with all the world.

Shortly after I had established myself in the home of Mr. Taylor, the county commissioners, with the county judge, J. Archuleta, and the county attorney, Jas. L. Russell, returned from New Mexico under an escort of sixty mounted and well armed Mexicans.

We revolutionists, about seventy-five strong, met them at the bridge spanning the San Juan river, and prevented them from entering the town.

Communications were carried on through flags of truce. Our side were mostly wild and woolly cowboys and ranchmen, and we had plenty of liquor to keep up our fighting spirit.

The county officials were camped in an old house on the opposite side of the swift flowing San Juan river, while their armed escort were housed in the vacated government barracks, a quarter of a mile distant from the river.

A plot was laid to assassinate the seven officials at 3 A. M. Two men were to cross the river above town and slip along under the bank to a haystack which adjoined the house in which the officials slept. The hay-stack was to be set on fire. This would burn the house. Men secreted behind

rocks on our side of the river were to shoot down the gentlemen as they ran out of the burn-ing building.

About 11 P. M. I waded the river half a mile above town and made a swift run to notify the armed guards doing duty at the old government barracks.

Jose Martinez, brother to Bendito Martinez, promised that he would give me ample time to get back to the saloon where our mob was congregated, before notifying the officials. But this he failed to do; the result being that our guards on the bridge saw the officials running with their valises over to the camp of their fighting men. Then the drunken mob began counting noses to see who of their party were absent to have warned the enemy. Of course, I was missed. Hence when I returned there was something "doing," and they were determined to hang me. But my friends, Taylor, Dyke and Gordon, believed my protests of innocence and my life was spared.

They decided to set a trap for me the next night. They concluded that if I were the guilty party I must have communicated the secret to Mrs. Scase, and she sent the news to her husband by one of her small boys. It puzzled them to know how I could have waded the swift river, which was waist deep, without wetting my clothes. They had felt to see if they were wet. They did not know that I disrobed while crossing the river.

County Commissioner Scase had a Mexican wife, and when the mob burnt up their residence and livery stable and escorted Mr. Scase over the line into New Mexico, they allowed Mrs. Scase and her children to occupy an old shack on the bank of the San Juan. So at this shack the trap was set to catch me. They felt sure that if I were a detective I would communicate with Mrs. Scase.

Therefore, they had two men detailed to watch this shack. They secreted themselves in a large wood pile near the front door. These men took turns about guarding.

We had a dance that night. All attended but the men on duty guarding the bridge and the Scase shack.

About 11 P. M. I walked in a round-about-way to the Scase residence to deposit some short hand notes in the back of an old oil painting which hung on the wall, and which had escaped the fire. I passed within a few yards of the wood pile where the armed

guard was doing duty.

Securing the door key under a board—where Mrs. Scase had promised to leave it—I entered the front room and deposited the notes. Then I sat on the edge of the bed talking to Mrs. Scase a moment. The children were sound asleep. In taking my departure I slipped a board out of place along the wall, facing the river, and made a jump of about twelve feet onto the rocky edge of the river.

Mrs. Scase replaced the board. As soon as I entered the door the young man in the wood pile ran to the dance hall to tell the half drunken mob that the suspect was caught in the trap. All grabbed their rifles or shotguns and raided the Scase shack. I was told that Mrs. Scase stood pat and insisted that I had not been there.

When I entered the dance hall the ladies and children turned their gaze onto~. There were no men in the place but the two fiddlers. A runner was sent to inform the mob that I was in the hall.

In' a few moments the hall was a surging mass of armed men. Gordon G. touched me on the shoulder, saying: "Anderson, I want to speak to you." He led the way into a side room where there was a carpenter's work bench, and pointing to this bench, he asked me to sit down as he wished to ask me some questions. Around my waist were old Colt's 45 and a pearl-handled bowie knife. My first impulse was to draw the pistol and fight my way out, but on second thought I concluded that would be showing bad detective ability.

I sat down on the bench facing Gordon, who stood six feet in his stockings, and was otherwise every inch a man. Placing both hands on my knees and looking me square

in the face, he said: "Now, anderson, I want you to tell me the truth. If you do I can save you, otherwise you are going to be killed. Now, remember, don't lie to me. I want the truth. Are you a detective?" **To Be continued. . .**

BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ARCHULETA, COLORADO

AN ORDINANCE PROVIDING FOR THE LAWFUL, CONSTITUTIONALLY OBEDIENT FILING AND RECORDING OF AN INTERNAL REVENUE SERVICE EMERGENCY ORDINANCE.

"NOTICE OF FEDERAL TAX LIEN," NO. _____, 2009 (PERFECTED) FEDERAL TAX LIEN, OTHER FEDERAL TAX LIENS AND RELATED DOCUMENTS INTO THE PUBLIC RECORD OF THE COUNTY OF ARCHULETA, COLORADO TO PROTECT THE RIGHTS AND PROPERTY OF THE SOVEREIGN PEOPLE AND CITIZENS OF THE COUNTY OF ARCHULETA.

BE IT ORDAINED BY THE COMMISSIONERS OF THE COUNTY OF ARCHULETA:

WHEREAS, the current practice of filing Notice of Federal Tax Liens, herein after known as NOFTL, manifestly violates the Constitutionally protected Due Process rights of the Sovereign People and of the Citizens of the County of Archuleta, and;

WHEREAS, the current practice of filing NOFTL violates the Right of the Sovereign People and of the Citizens to be secure in their persons, houses, papers and effects, from unreasonable search and seizure secured to them in perpetuity by Article IV of Amendment First to the Constitution of the United States of America (AD 1789/1791) as well as Article 1 section 9, Colorado Constitution (AD 1859) and Article IV, and;

WHEREAS, the current practice of filing these NOFTL is manifestly an accroachment upon the sovereignty has caused the Sovereign People and the Citizens of the County of Archuleta irrevocable and irreparable damage to their persons and property, and;

WHEREAS, the Sovereign People and the Citizens of the County of Archuleta created and formed the Board of Commissioners of the County of Archuleta; who swore an oath to protect and uphold said Constitution, the Supreme Law of the land of the United States of America and the Constitution of the State of Colorado; for the express purpose of protecting, defending and securing the Rights of the Sovereign People and of the Citizens of the County of Archuleta including the faithful defense and protection of same from all enemies both foreign and domestic, and;

WHEREAS, by virtue of the mandatory Oath to "support this Constitution" at Article VI of said

Constitution of the United States of America (AD 1789/1791), it has always been the personal obligation and fiduciary duty of each Commissioner of the Board of Commissioners of the County of Archuleta, to defend and protect the private property rights of the Sovereign People and of the Citizens said Board was created to serve, and;

WHEREAS, on the basis of antecedent Fundamental Law and res judicata relating thereto, a bona fide LIEN is not perfected for execution purposes unless based upon a claim of obligation supported by verified facts and, upon proper notice thereof, is administratively unchallenged for a prescribed period of time or, if timely challenged, has been adjudicated by a court of competent jurisdiction on the basis of the verified supporting facts; and

WHEREAS, the Clearfield Doctrine makes manifest that neither the IRS nor any other governmental agency enjoys any privilege, immunity or exemption from the requirements of the aforesaid Lawful lien process whereby a mere unsupported claim of lien (NOFTL) may be officially recorded as a Lawfully perfected Federal Tax Lien for purpose of execution thereupon; and

WHEREAS, the evidence presented to this Commission by the Colorado Lawmen ad hoc Steering Committee is overwhelming and compelling as to the proper, Lawful way to file and record a NOFTL and/or Lawfully perfected Federal Tax Lien,

THEREFORE, we the County of Archuleta Board of Commissioners do hereby resolve and do hereby ordain and enact as follows: Archuleta County Emergency Ordinance # _____ dated _____, 2009 mandating the following process and procedure to be followed and adhered to for the recording of NOFTL and Lawfully perfected Federal Tax Liens into the official records of the County of Archuleta, State of Colorado:

1. Every NOFTL or Lawfully perfected Federal Tax Lien must include a complete copy of IRC section 6331, showing scope and limitation of authority regarding who is subject to and liable for taxes, in a print font not smaller than 12 point, and;

2. Every NOFTL and Lawfully perfected Federal Tax Lien received by the County of Archuleta Recorder of Conveyance or any and every other official thereof, elected or appointed to carry out this duty, shall, from this day forward:

a. Verify that the appropriate documentation, certification, verification, and sworn affidavit be personally signed in his or her true and Lawful name in front of the

County of Archuleta Clerk/Recorder of Conveyance, by the Internal Revenue Special Agent, Criminal Investigator, Enforcement Officer or Revenue Recovery Officer, under penalty of perjury, as being true, correct, certain, and complete and;

b. Ensure that the foregoing authentication, as set forth in subsection 1. above, shall accompany every NOFTL or Lawfully perfected Federal Tax Lien, before the filing or recording thereof in the County of Archuleta records, and;

c. Ensure that the foregoing authentication, as set forth in subsection 1. above, shall accompany each and every NOFTL or Lawfully perfected Federal Tax Lien, before placing thereon or affixing thereto the official seal/stamp of the County of Archuleta Recorder of Conveyance; and;

3. Any presentment to the County of Archuleta Clerk/Recorder of Conveyance or any other official thereof, weather elected or appointed to carry out this duty, of any NOFTL or Lawfully perfected Federal Tax Lien by anyone acting in the capacity of Internal Revenue Special Agent, Criminal Investigator, Revenue Recovery Officer or Enforcement Officer, shall be hand delivered in person by same and accompanied by:

a. A positive IRS color photo identification card and pocket commission of said officer, of which a copy shall be taken thereof and filed in the County of Archuleta records with the NOFTL or Lawfully perfected Federal Tax Lien being presented for filing or recording; and;

b. A thumb print of the right hand of said officer making presentment; and

c. Written proof of Delegation of Authority from the Secretary of the Treasury of the United States of America specifically to said officer making the presentment; and

d. The work and personal residence/domicile of the Internal Revenue Special Agent, Criminal Investigator, Enforcement Officer or Recovery Revenue Officer making the presentment (in the event service upon said officer is needed), and;

e. The verified name, address/domicile and telephone number of said officers surety/bonding company, and;

4. Proof of Certification of NOFTL or Lawfully perfected Federal Tax Lien being presented in accordance with the requirements of Colorado Law, codified as ORS 87.811, must be appended thereto before entry thereof into the official records of the County of Archuleta; and

5. IRS Form 23C Assessment Certificate-Summary Record of Assessment and a IRS form 4340 bearing on its face a valid Office of

Management and Budget (OMB) number, signed and dated by the Assessment Officer, must be appended to each NOFTL or Lawfully perfected Federal Tax Lien presented for recording, and;

6. All forms/papers/documents from the IRS shall include accurate and complete general English language definitions for all acronyms as well as all coded or encrypted information appearing on the face thereof and MUST conspicuously display a valid Office of Management and Budget (OMB) number, which shall be verified by County of Archuleta Clerk/Recorder of Conveyance or their representative, through the Office of Management; and Budget; and

When all of the foregoing reasonable, lawful acts and information has been performed, verified and accounted for, then and only then shall the above listed information, documentation, certification, et al entitle the NOFTL or Lawfully perfected Federal Tax Lien to be date/time stamped and have the County of Archuleta Recorder of Conveyance official seal/stamp affixed thereto and the said documents then be recorded in the appropriate permanent alphabetical Lien Index file, in accordance with the requirements of Colorado Law, codified as ORS 87.811; and;

BE IT FURTHER RESOLVED; hereinafter, NO NOFTL or Lawfully perfected Federal Tax Lien shall be electronically transmitted to the County of Archuleta Clerk/Recorder of Conveyance, and all NOFTLs or Lawfully perfected Federal Tax Liens hand delivered for filing and/or recording that do not fully comply with and are not accompanied by ALL the above listed verification(s) and certified documentation, as prescribed by law, shall be stamped RETURNED FOR CAUSE-FRAUD and marked only with the time/date stamp, and then copied, which copy shall then be placed in an appropriate sub index file in the County of Archuleta Clerk/Recorder of Conveyance Lien Index titled NON-NEGOTIABLE NOTICE OF CLAIM OF FEDERAL TAX LIEN INDEX and the original(s) thereof returned to the one making presentment or, if refused, returned to the appropriate IRS office.

BE IT FURTHER RESOLVED; each and every NOFTL shall be filed in a file named "NON-NEGOTIABLE NOTICE OF CLAIM OF FEDERAL TAX LIEN INSTRUMENT FILE INDEX," and each and every lawfully perfected Federal Tax Lien shall be filed in a file named "PERFECTED FEDERAL TAX LIEN FILE INDEX," and each and every other class or

type of perfected Federal Lien shall be filed in a file named "PERFECTED FEDERAL LIEN FILE INDEX," each aforesaid index to be kept separate from the other(s) and each and every NOFTL, perfected Federal Tax Lien or other Federal Lien accepted for filing shall be legibly stamped as to which file index it has been recorded.

BE IT FURTHER RESOLVED; and hereby ORDAINED: This Ordinance is here by adopted, and from this day forward, the foregoing is the process that shall be followed and implemented upon signing by this Board of Commissioners of the County of Archuleta, Colorado, who have sworn an Oath to uphold and support the Supreme Law of the land, (AD 1789/1791) the Constitution of the United States of America and the Constitution of Colorado (AD 1859) to the benefit of the sovereignty and to serve and protect the rights and property of the Sovereign People and of the Citizens of the County of Archuleta, Colorado.

BE IT FURTHER RESOLVED; that anyone who suffers injury, damage or loss in their person, property, reputation or otherwise, as a consequence of non-compliance by any government agency or official, with this Ordinance # _____, shall have right of action, civil and/or criminal, against all and any offending perpetrators and their accessories, in their respective private and individual capacities, whether such cause of action arises from malfeasance, misfeasance, nonfeasance or breach of fiduciary duty; and that the only superceding Law allowed to be considered as governing any cause of action arising under this Ordinance # _____ or any challenges to the Constitutionality of this Ordinance # _____,

in all or any of its parts, shall be limited strictly to the Constitution of the United States, as such being the Supreme Law of the Land (AD 1789) within the purview of the Declaration of Independence (July 4, 1776), and as such Constitution is restricted by Articles I thru X of Amendment First thereto (AD 1791). This section shall be liberally construed in favor of any injured party seeking redress hereunder.

DEFINITIONS for this ORDINANCE:

accroachment: an encroachment; illegally exercising power without specific lawful of legal authority.

antecedent: Fundamental law: by laws, customs or common laws proceeding the constitution and organic laws.

bona fide: authentic and genuine in nature, without any intention to deceive.

authentication: the act of proving that something (as a document) is true or genuine, esp. so that it may be admitted as evidence; the condition of being so proved.

Certificate: a document in which a fact is formally attested to as true.

certification: the act of attesting. The state of having been attested.

citizen: a person entitled to all of the protections as set forth and delineated as being applicable to the People of the United States, as such individuals are defined in the Preamble to the Constitution and as such political class is protected in the First Ten Amendments to the Constitution of the United States of America, not withstanding the debilitating provisions of the Fourteenth Amendment; and who are likewise entitled to the protective provisions set forth in the Constitution of the State of Colorado. For the purpose of this Ordinance - the word "citizen" and the word

"people" and the term "People of the United States" are declared to be synonymous and equal in every respect notwithstanding the implied intention otherwise as set forth in the Preamble to the Constitution of the United States.

Clearfield Doctrine:

Governments descend to the political status level equal to that of a mere private corporation and where the government takes on the political status character equal to that of a mere private citizen where private corporate commercial paper Federal Reserve Notes are concerned. For purpose of suit, such corporations and individuals are regarded as an entity entirely separate from government.

conveyance: the voluntary transfer of a right to property from one owner to another.

lien: the legal right or interest that a creditor has in another's property, lasting usually until a debt or duty that it secures is satisfied.

oath: a solemn declaration, accompanied by a swearing to God or a revered person or thing, that ones statement so given is true or that one will be bound to a promise so sworn, under penalty of law.

perpetuity: without end.

seal: an impression or sign that has legal consequence and authentication when applied to an instrument or document.

service: formal delivery of a writ, summons or other legal process. Process of service.

Sovereign People: individual men and women holding absolute supreme authority over themselves; individually, independent of any and all other authority of every nature what-so-ever.

sovereignty: supreme and independent political authority, held by an individual man or woman as a birthright or as delegated to government.

status: standing; state or

condition; social or political position. The lawful or legal relation of individuals to the rest of the community, the rights, duties, capacities, and incapacities which determine a person as a member of a given social or political class. A lawful or legal personal social or political relationship, not temporary in its nature nor terminable at the mere will of adverse parties, with which third persons and the state are concerned.

verification: confirmation of correctness, truth, or authenticity, by affidavit, oath, or deposition to assure good faith averments or statements of the party.

This EMERGENCY ORDINANCE # _____, 2009 may be subject to judicial review and should invalidation be decided by a court of competent jurisdiction, a detailed, point by point findings of facts and conclusions of law shall be provided in writing and on the record at the time of such invalidation. Failure to so provide shall immediately invalidate any such invalidation as though such invalidation had not occurred;

The parties are entitled to know the findings and conclusions on all of the issues of fact, law, or discretion presented on the record. Butz v. Economou 438 U.S. 478, 98 S.Ct. 2894, 57 L.Ed. 2d 895 (1978). Federal Maritime Commission v. South Carolina States Ports Authority 535 U. S. 743, 122 S. Ct. 1864, 152 L.Ed. 2d 962, (2002).

THEREFORE: Be enacted with full force and effect this ____ day of the ____ month, AD 2009, by the Board of County Commissioners of The County of Archuleta, State of Colorado. Witness our hands:

If you have never read through these documents, or simply don't remember what they say, you will be amazed at where we are now in the Rule of Law in this country and how far we have strayed from our founding documents, to our financial and other detriment.

Many elements within these documents will be addressed in future articles and investigation as to how this supreme law of the land is being broken every minute of every day across the 50 States. This is unacceptable for a free people and we all need to become more involved with where we are headed. It really doesn't take a huge, impossible effort... just some courage, some cooperation, and some fortitude, just as our founding ancestry showed in bringing us the freedoms we now enjoy. Let the journey begin, and let's take back our country, our laws and our freedoms!

THE DECLARATION OF INDEPENDENCE:

In Congress, July 4, 1776,

THE UNANIMOUS DECLARATION OF THE THIRTEEN UNITED STATES OF AMERICA

When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the Powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty, and the pursuit of Happiness.

That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed. That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shown, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object, evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.

Such has been the patient sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present King of Great Britain is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these States. To prove this, let Facts be submitted to a candid world.

He has refused his Assent to Laws, the most wholesome and necessary for the public good. He has forbidden his Governors to pass Laws of immediate and pressing importance, unless suspended in their operation till his Assent should be obtained; and when so suspended, he has utterly neglected to attend to them. He has refused to pass other Laws for the accommodation of large districts of people, unless those people would relinquish the right of Representation in the Legislature, a right inestimable to them and formidable to tyrants only.

He has called together legislative bodies at places unusual, uncomfortable, and distant from the depository of their public Records, for the sole purpose of fatiguing them into compliance with his measures.

He has dissolved Representative Houses repeatedly, for opposing with manly firmness his invasions on the rights of the people.

He has refused for a long time, after such dissolutions, to cause others to be elected; whereby the Legislative powers, incapable of Annihilation, have returned to the People at large for their exercise; the State remaining in the mean time exposed to all the dangers of invasion from without, and convulsions within.

He has endeavoured to prevent the population of these States; for that purpose obstructing the Laws of Naturalization of Foreigners; refusing to pass others to encourage their migrations hither, and raising the conditions of new Appropriations of Lands.

He has obstructed the Administration of Justice, by refusing his Assent to Laws for establishing Judiciary powers.

He has made Judges dependent on his Will alone, for the tenure of their offices, and the amount and payment of their salaries.

He has erected a multitude of New Offices, and sent hither swarms of Officers to harass our People, and eat out their substance.

He has kept among us, in times of peace, Standing Armies without the Consent of our legislatures.

He has affected to render the Military independent of and superior to the Civil power.

He has combined with others to subject us to a jurisdiction foreign to our constitution, and unacknowledged by our laws; giving his Assent to their Acts of pretended Legislation:

For quartering large bodies of armed troops among us:

For protecting them, by a mock Trial, from Punishment for any Murders which they should commit on the Inhabitants of these States:

For cutting off our Trade with all parts of the world:

For imposing Taxes on us without our Consent:

For depriving us in many cases, of the benefits of Trial by Jury:

For transporting us beyond Seas to be tried for pretended offences:

For abolishing the free System of English Laws in a neighbouring Province, establishing therein an Arbitrary government, and enlarging its Boundaries so as to render it at once an example and fit instrument for introducing the same absolute rule into these Colonies:

For taking away our Charters, abolishing our most valuable Laws, and altering fundamentally the Forms of our Governments:

For suspending our own Legislatures, and declaring themselves invested with power to legislate for us in all cases whatsoever.

He has abdicated Government here, by declaring us out of his Protection and waging War against us.

He has plundered our seas, ravaged our Coasts, burnt our towns, and destroyed the Lives of our people.

He is at this time transporting large armies of foreign mercenaries to compleat the works of death, desolation and tyranny, already begun with circumstances of Cruelty & perfidy scarcely paralleled in the most barbarous ages, and totally unworthy the Head of a civilized nation.

He has constrained our fellow Citizens taken Captive on the high Seas to bear Arms against their Country, to become the executioners of their friends and Brethren, or to fall themselves by their Hands.

He has excited domestic insurrections amongst us, and has endeavoured to bring on the inhabitants of our frontiers, the merciless Indian Savages, whose known rule of warfare, is an undistinguished destruction of all ages, sexes and conditions.

In every stage of these Oppressions We have Petitioned for Redress in the most humble terms: Our repeated Petitions have been answered only by repeated injury. A Prince, whose character is thus marked by every act which may define a Tyrant, is unfit to be the ruler of a free people.

Nor have We been wanting in attention to our British brethren. We have warned them from time to time of attempts by their legislature to extend an unwarrantable jurisdiction over us. We have reminded them of the circumstances of our emigration and settlement here. We have appealed to their native justice and magnanimity, and we have conjured them by the ties of our common kindred to disavow these usurpations, which would inevitably interrupt our connections and correspondence. They too have been deaf to the voice of justice and of consanguinity. We must, therefore, acquiesce in the necessity, which denounces our Separation, and hold them, as we hold the rest of mankind, Enemies in War, in Peace Friends.

We, therefore, the Representatives of the united States of America, in General Congress, Assembled, appealing to the Supreme Judge of the world for the rectitude of our intentions, do, in the Name, and by Authority of the good People of these Colonies, solemnly publish and declare, That these United Colonies are, and of Right ought to be Free and Independent States; that they are Absolved from all Allegiance to

the British Crown, and that all political connection between them and the State of Great Britain, is and ought to be totally dissolved; and that as Free and Independent States, they have full Power to levy War, conclude Peace, contract Alliances, establish Commerce, and to do all other Acts and Things which Independent States may of right do. And for the support of this Declaration, with a firm reliance on the Protection of Divine Providence, we mutually pledge to each other our Lives, our Fortunes and our sacred Honor.

or global currency. Schiff commented, "What's going to happen, of course, is that when inflation starts running out of control and prices start going through the roof, the Government is again going to focus on the symptoms and not the disease and introduce price controls on energy, on food, on a lot of things which are vital – which means shortages, which means long lines, black markets and civil unrest. All this stuff is coming, if we don't stop... ..And we're giving the Government so much power.

We're giving up so many civil liberties – when you have Martial Law and you've got the military policing the streets, when you've got suspension of habeas corpus, when you've got curfews so you can't be out of your house after dark and they can just pick you up and put you in prison and just hold you there without charges and there's nothing you can do about it. I mean we're giving up one liberty after another: all to protect ourselves from this economic crisis, which needs to happen anyway..."

The Weimar Republic came to an end in 1933 with the rise of Adolf Hitler. After the Reichstag Fire, later discovered to be set by Hitler's men, Hitler invoked Article 48 and suspended key provisions of the Weimar Constitution that protected civil liberties.

Soon, dissenting voices were rounded up and transported to camps; millions died as a result. War soon returned to German soil.

It is a little late to be taking a history lesson from the Weimar playbook, unless you want to make sure you follow every play.

we run the risk of losing more than we bargained for.

We gamble with our health when we make the choice to save a little now hoping that we won't get sick in the future. For those who have taken that gamble and lost, they know all too well the cost. They find out first hand that the cost of being sick far outweighs the cost of staying healthy.

In this model, the money we spend on healthcare is a reactionary expense – short term spending with no long term benefit. Although the care may address the symptom in the present, not supporting or strengthening the system, leaves the body susceptible for additional problems in the future. Chronic health conditions require continued monitoring through doctor's visits and continued use of medications to keep the symptoms at bay. Add to this the potential for side effects and additional health concerns, and for those with insurance coverage, ever increasing premiums. Personally and financially, this model is a downward spiral.

So what are we to do? The answer lies not in what we do but in how we think. As Albert Einstein so eloquently explains: "You cannot solve a problem from the same level of thinking that existed when the problem was created." So let us begin.

We have been taught that the

absence of symptoms equates to health. Therefore, we do not define the term "health" by what we do have (energy, vitality, mental clarity, joy, etc.) but by what we don't (sickness and symptoms). As illustrated above, when we approach our healthcare from this definition, the money we spend becomes an ongoing and ever increasing expense.

Investing in our health, on the other hand, provides us with long term benefits with a return on our investment. As with financial investment, we look beyond the short term and set our sights to what we ultimately want to create. For example, if we focus on getting out of debt, and we meet our goal, we only accomplish "just getting by." However, if our focus is on generating wealth and abundance, we will pass "just getting by" along the way. With our focus on creating monetary wealth, the actions we take will move us closer to that end. We become more conscious of how our money is being spent and make sure that our money is working for us.

Applying the investment principle to our health, by shifting our focus from managing our symptoms to creating true vitality, we begin to take actions consistent with what we want to create. As we take actions that support us and develop a higher level of health, we begin to feel more in control and more empowered. We begin

to notice that our bodies are more capable of healing than we have been taught. We begin spending our healthcare dollar on things that will create long term benefit and stability.

Interestingly, many aspects of investing in our health will actually reduce the monetary outlay. Much like changing the oil in your car will save you the expense of having to replace a seized engine in the future, spending on our health in the short term will reduce our expenditures in the long term. Also, being smarter about where we place our dollar will add additional value. For example, we truly are what we eat. The food choices we make can contribute to increasing our health while reducing our grocery bill. If we are going to spend the money anyway, what will we choose to spend it on?

When economic times get tough we need to make sure that we have something to fall back on. My grandmother used to say "At least we have our health." Those words have a more powerful meaning now more than ever. With our healthcare system failing and expenses on the rise, we need to take back our health and go forward proactively. Those that will weather this economic storm will be those that have invested in themselves!

regarding applying for a recent State-legislated grant fund for this very project, which has a deadline of March 13th, 2009 to apply for. This money would help establish a working system that we can all support and be minimizing dump runs, and be setting the standard for such projects.

Contact our County Commissioners on this. If someone knows about this grant, contact us and we'll see what we can do to get it going. It should be County Government that applies for this money.

Let's do some brainstorming on ideas as to how to make this work and what would be convenient for everyone to get involved with recycling. It isn't hard... you throw the stuff in a can anyway, so why not simply throw it in a specific can?


