## **Request for Convening of Grand Jury for Archuleta and LaPlata Counties**

The Grand Jury is the people's means to hold government officials and others accountable for their actions. This is a constitutional right to all people to have access to the Grand Jury, and to be able to present evidence to initiate investigations, and to bring indictments.

I \_\_\_\_\_ as part of the collective people of \_\_\_\_\_ county, do hereby officially request the immediate establishment of a Grand Jury for the investigation into multiple areas of local county government. Available documentation provided by multiple parties establishes a clear link between county official's activities at multiple levels, and criminal and civil violations of unparalleled depth.

I am extremely concerned about corruption in my county and the evidence supports the following activities:

Fraud, Racketeering/RICO crimes, denial of Due Process rights, violation of Oath of Offices, oppression, malfeasance, misfeasance, and nonfeasance, abuse of process, malicious prosecution, financial fraud, misuse of funds, false documentation, securities violations, fraudulent foreclosures, violation of Separation of Powers Clauses of the Constitution, wonton disregard for Constitutional Law and the Colorado Constitution, and civil rights, collusion between parties bent on criminal actions, suppression of evidence, obstruction of justice, violations of Colorado Open Records Act, violations of Federal election rules and procedures, "willful" oppression, selective prosecution, encroachment/ violation of separation of powers, false arrest, false imprisonment, civil conspiracy, intentional deprivation of meaningful access to court, customary loss of property prior to due process, prosecution of criminal cases where judge, prosecutor, and alleged plaintiff are all state actors, conflict of interest, non-judicial foreclosures absent requisite documentation of standing/real party in interest as required and without production of original promissory note to be produced for marking under CRCP Rule 121, Section 1-14(1)(f), etc.

I officially and respectfully request that you initiate all procedures for considering all evidence for criminal activities from available sources, and to initiate a Grand Jury selection of respective county residents from a list of legally qualified residents, proven to have no conflict of interests
