## Two French students, working on the real origins of bird flu, tortured, killed in London

Two French biochemical students, Laurent Bonomo and Gabriel Ferez, were murdered by Israeli Mossad-British intelligence assassination teams on June 29, 2008. Both Bonomo and Ferez were studying at the prestigious London Imperial College researching the origins of bird flu and the link to the alleged vaccines.

The murders were first revealed by France's Directorate for Internal Security, not by Britain's Scotland Yard, making it likely that the students were French intelligence officers. London police arrested Daniel Sonnex, 23, and Nigel Edward Farmer in the killings. A joint French-U.S. Intelligence anti-terrorist task force in Paris, headed by former Secretary of State Colin Powell and former head of French intelligence Jean Crouzet, for years has monitored the activity of the Israeli mercenaries. The patriotic American-French team has allegedly prevented various scripted terrorist attacks, i.e. false flags, on both the United States and Europe, with the planning of the attacks actually originating inside the compromised intelligence agencies of the United States, the United Kingdom, Israel and Germany, according to task force sources.

The two researchers had discovered that the alleged bird flu vaccine, H-7, which was designed to neutralize and stop the H5N1 avian flu virus, had been spliced using DNA to actually create a vaccine and an illness producing virus at the same time. The French students had also discovered that the bird flu vaccine, i.e. a virus, had links to U.S., British and Israeli laboratories associated with the noted Mossad agent, Dr. Philip M. Zackerie. Israeli microbiologist Zackerie, known as "Dr. Zack," worked for the U.S. bio-weapons lab at Ft.

Detrick, Md., where he was photographed handling the strain of anthrax used in the post 9-11 attack according to published reports. He was a consultant at the FBI linked company Gilead Sciences Inc. of Boulder, Colo. Gilead Sciences has been linked to the 9-11 anthrax strain and to the bird flu vaccine.

The two French students, who had their apartment broken into one week before their brutal assassination, also had their lap-top computer stolen and their apartment fire-bombed. The operation has been traced to a team of 10 Israeli Mossad and British MI5 agents. The two individuals currently under arrest in the United Kingdom were witnesses to the murders, according to task force sources, and their lives are in jeopardy. The assassination of Bonomo and Ferez happened just after the recent meetings that took place in Northern Ireland between President George Bush, former President Bill Clinton and current British Prime Minister Gordon Brown.

**The two murders also may be related to the recent alleged assassination attempt on French President Nicolas Sarkozy and Israeli Prime Minister Ehud Olmert in Ben Gurion International Airport in Israel.**

**Officially, an Israeli border patrol officer who was a member of the Druze community shot himself as Sarkozy and his wife were mounting the stairs to their plane. The man's body then fell from the top of the building where he had been perched. Many believe he was an Arab patsy-to-be before the assassination attempt went awry.**

**Sarkozy was also aware of the bird flu treason and plans to use it against France as well as the Israeli Mossad hacking of French INTERPOL Internet portals using the U.S. National Security Agency and a headquarters in Amsterdam. Earlier this evening, Alex Jones' flagship website, Infowars.com, came under a concerted denial of service (DoS) attack. It is unavailable at the time of this report.

The attacks are coming out of Japan. A Whois database search reveals the origin to be the Asia Pacific Network Information Centre in Milton, Australia. DoS attacks usually consist of concerted efforts to shut down a web server by flooding the computer with requests and consuming its resources so that it is no longer available to users. DoS attacks commonly constitute violations of the laws of individual nations. Over the last few days, Alex Jones and his websites have covered the so-called swine flu "pandemic" and have built a solid case that the outbreak is part of a larger campaign by the government to frighten the populace and institute martial law as specifically detailed in the Department of Defense's "Implementation Plan for Pandemic Influenza" and other government documents. Alex Jones is the primary media source calling the government's bluff on the bogus "pandemic" elevated earlier today to a level 5 under World Health Organization guidelines.

WHO Director-General Margaret Chan declared the phase 5 alert after consulting with flu experts from around the world. "All countries should immediately now activate their pandemic preparedness plans," Chan told reporters in Geneva. "It really is all of humanity that is under threat in a pandemic." "All countries should



immediately activate their pandemic preparedness plans,” the WHO declares. “This change to a higher phase of alert is a signal to governments, to ministries of health and other ministries, to the pharmaceutical industry and the business community that certain actions should now be undertaken with increased urgency, and at an accelerated pace.”

The Department of Homeland Security’s National Response Plan follows the same criteria in the case of a flu pandemic or terrorist attack and relies on the military — specifically the Northern Command — to respond to such events. Alex Jones has featured a number of guests on his nationally syndicated radio show in the last few days that have outlined the government’s plan to use a bogus pandemic as an excuse to impose martial law and engage in forced vaccination. TORONTO — The alarm now sounds with increasing frequency and urgency: the world could be on the brink of an influenza pandemic sparked by the highly virulent avian flu strain ravaging poultry stocks in Southeast Asia, experts fear. But can that strain -- known as H5N1 -- actually acquire the ability to spread easily to and among people? And if it can, how likely is that dreaded event to occur?

Early in the new year, U.S. scientists will begin experiments that should provide some answers to those questions. In the process, they hope to learn more about why a virus that nature designed to infect migratory water birds has the astonishing capacity to kill mammal species ranging from house cats to tigers to humans. The work won't indicate how soon a pandemic might start. And the findings can't be taken as a guarantee the virus will evolve as the science predicts. "Like a lot of science, it's an imitation of nature," explains Dr. Frank Plummer, scientific director of Canada's National Microbiology Laboratory.

"It doesn't replicate exactly what happens. But I think it gives you an idea of the propensity of the H5N1 virus to do this thing." The researchers, from the influenza branch of the Centers for Disease Control in Atlanta, will mate H5N1 and human flu viruses in a process known as reassortment. Viable offspring will be tested in animals thought to be good surrogates for humans, to see if the viruses can infect, can be transmitted easily from infected animals to healthy ones and to note the severity of disease each provokes. In other words, the CDC researchers will be deliberately engineering viruses of pandemic potential. It's high-risk but crucial work, the influenza community insists.

"It's a dangerous experiment," admits Dr. Robert Webster, a world-renowned expert on influenza based at St. Jude Children's Research Hospital in Memphis, Tenn. Still, Webster has no doubt the work needs doing. Science must gain a better understanding of the menacing H5N1 virus. "These experiments are fully justified,

knowing what we know," he stresses, using a scatological adjective to describe how scared influenza experts are of H5N1. "This is the worst virus I've ever met in my long career."

The World Health Organization has been pleading for months for qualified research facilities -- of which there are few -- to undertake this work. The Geneva-based agency would like to be able to put some kind of odds on how likely H5N1 is to become a pandemic strain and how deadly -- or not -- H5N1 reassortment viruses might be in humans. If none of the hybrids cause severe disease, the organization might feel comfortable with stepping down its current high level of alert, explains Dr. Klaus Stohr, director of the WHO's global influenza program. On the other hand, if CDC researchers easily produce highly transmissible and lethal hybrids, "that would certainly add to our concern." It's about quantifying risk.

"Currently we do risk-speculation, but we want to do risk-assessment. And that will give us scientific evidence on the possible outcome on the emergence of a pandemic virus," Stohr says. "It will give us an opportunity to predict the probability because we will have an understanding on the number of reassortment viruses which are viable, the percentage of those that are viable which are then transmissible -- and also on the percentage of those which are viable, transmissible and pathogenic. And how pathogenic they are." The CDC researchers will work in high containment level 3-enhanced labs, says Dr. Nancy Cox, the leading influenza authority who heads the agency's flu branch. The labs have special features designed to protect both the health of the workers and the world against a viral escape.

"It's not typical level 3," Cox says, adding the lab workers are "extremely cognizant of the danger of the H5 viruses." "And of course we know we can autoclave these viruses," she adds, referring to a process that kills using high pressure and heat. "So if you find something that is particularly worrisome, you can get rid of it." Still, lab accidents happen. Since SARS was contained in mid-2003, four lab workers in Asia have infected themselves with the potentially deadly disease and one spread it beyond the walls of the laboratory. Earlier this year, a Russian lab worker died after accidentally infecting herself with Ebola virus. Given that reality, some groups have raised concern that work like this should not be done. But a top virologist from the Netherlands insists it must be, expressing confidence in the CDC's ability to do the job safely.

"If it's being done by CDC, then the good thing about that is that safety measures will properly be in place," said Dr. Albert Osterhaus, of the Erasmus Medical Centre in Rotterdam. The CDC researchers will mix genes from H5N1 with genes from circulating strains of human flu to see which combinations produce viruses that grow and infect. Cox says H3N2 -- the strain that has been responsible for most human flu in recent years -- will be the first priority. However, Southeast Asia has recently seen activity with H1N1, the mild modern descendant of the strain that caused the Spanish flu of 1918. So the CDC has been sequencing H1N1 viruses recently isolated in Thailand to be able to work with it as well. "We're really keeping our minds open. But as long as H3N2 viruses continue to predominate, that will be our first target," Cox says.

Reassortment studies can be performed two ways, she explains. Scientists can use reverse genetics, a procedure that allows them to custom tailor a virus with a predetermined constellation of genes from each parent virus. The other alternative is what Cox describes as the classical way -- simultaneously infecting tissue culture with H5N1 and H3N2 viruses and seeing what results. That approach is more time-consuming and laborious, but more closely mimics evolution of influenza viruses in nature. "We will probably be using a combination of the two different methods. I think there are advantages and disadvantages to each," says Cox, who believes her team may have some preliminary results within a couple of months of beginning the work.

Some skeptics have pointed to the fact H5N1 hasn't yet reassorted to argue it may not be able to do so outside of the artificial confines of a laboratory. Webster thinks that optimism is misplaced. He calls H5N1 "one of the most promiscuous viruses that we've ever seen. It would amaze me if it wouldn't mate with a human virus, given the opportunity." CDC researchers have already made hybrid viruses with H5N1, using versions of the virus isolated after it first caused human infections in 1997 in Hong Kong. "Some gene combinations could be

produced and others were not," is all Cox will reveal of that as-yet unpublished work. Even if, in this new round of experiments, CDC's researchers fail to produce a single viable hybrid virus, that doesn't prove H5N1 won't reassort in nature, experts say.

For one thing, flu viruses are constantly evolving. The viruses that the CDC will work with now -- isolated in 2004 -- are not identical to those from the 1997 outbreak. A combination that fails with the 1997 virus might work with a 2004 virus -- or a 2005 version. "Things in nature can happen that you can't replicate in the lab necessarily," stresses Plummer, whose lab is working on producing reassortments of H7N3, the strain behind last spring's avian flu outbreak in British Columbia. "Can you be sure that all possible virus reassortments have occurred? No. And fairly minor changes in viruses can make really huge differences in their biologic properties."

**Hybrid avian-human flu virus didn't spread in lab study** (I suspect that is why they reassociated it with the swine flu bug, trying to fix that problem and now it does spread)

Jul 31, 2006 (CIDRAP News) – In an experiment designed to mimic events that could launch an influenza pandemic, a synthetic influenza virus made by combining an H5N1 avian flu virus with a human flu virus turned out to be no more contagious in an animal model than the natural H5N1 virus, US scientists are reporting this week.

Researchers at the Centers for Disease Control and Prevention (CDC) made two hybrid viruses and infected ferrets with them, according to a report to be published in the Proceedings of the National Academy of Sciences. The viruses failed to spread from infected ferrets to healthy ones in neighboring cages. "We found that they [the viruses] were not able to transmit efficiently," said CDC researcher Dr. Jackie Katz, speaking at a Jul 28 teleconference. "In fact, they were also not as able to cause severe disease as the original H5N1 virus."

The deadly H5N1 virus has infected 232 people and killed 134 since late 2003, but it has not yet found a way to spread easily from person to person. But scientists fear the virus could pick up that ability if it combined, or reassorted, with a human flu virus, which could happen if someone became infected with both types simultaneously. The CDC set out to create such a hybrid and test it in ferrets. The animals are considered good models for flu virus research because their susceptibility to flu viruses is similar to that of humans.

CDC officials cautioned against taking much comfort from the experimental results. Although the synthetic hybrid didn't spread among the ferrets in the experiments so far, that doesn't mean the scenario couldn't happen in nature, they said. (Also, experts say the H5N1 virus could become transmissible through accumulated small

mutations, without reassortment.) "These data do not mean that H5N1 cannot convert to be transmissible from person to person; they mean it's probably not a simple process and more than simple genetic exchanges are necessary," CDC Director Dr. Julie Gerberding said at the teleconference.

The H5N1 virus used in the study was a strain collected in 1997, when the pathogen first infected humans in Hong Kong. The human flu virus used in the study was an H3N2 strain, which has been common in recent decades. The research involved four steps, according to Katz. First, investigators assessed whether the H3N2 and H5N1 viruses would spread in ferrets, whose cages were arranged so that viruses could spread via respiratory droplets. The human virus did spread efficiently, whereas the avian virus didn't, which signaled that the ferrets were serving as good models for human infection, Katz said. The next step was to generate reassortant viruses. "We made two viruses that contained surface protein genes from the H5N1 virus and internal genes from the human H3N2 virus," Katz said. "We found we could make these viruses and that some of them were viable."

Third, the scientists infected some ferrets with the hybrid viruses and waited to see if they would spread to healthy ferrets. The hybrid viruses caused less severe illness than the original H5N1 strain, and they failed to spread. Finally, the investigators wanted to know if the hybrid viruses would naturally mutate to become more transmissible if they were passed through several ferrets in succession. So the researchers infected ferrets and, after the ferrets showed symptoms, took nasal secretions and used them to infect other ferrets, repeating this step five times. Further, the researchers assessed whether the virus could spread more easily after all these generations or "passages."

"We found that the virus did not acquire any additional capacity to transmit efficiently from infected ferrets to healthy ferrets," Katz said. Katz didn't explain why the CDC used a 1997 strain of H5N1 instead of a more recent strain, but said more recent isolates will be used in further experiments. Later versions of both H5N1 and H3N2 will be used to make further hybrids for testing in ferrets, she said. Scientists have identified a number of mutations in the H5N1 virus since 1997. "We did test the more recent strains [of H5N1] for their ability to transmit, and like the 1997 strains, they could not transmit efficiently from one animal to the next," she said. "We need to continue to study this."

The CDC officials were asked whether reassortment "dumbs down" or weakens the virus. Katz replied that the hybrids were less virulent than H5N1, but cautioned that the results apply only to the 1997 strain. Gerberding commented, "The pandemics of 1957 and 1968 were caused by reassortant viruses. Those were not dumb viruses." In answering other questions, Katz said some scientists believe the 1918 pandemic virus, unlike the 1957 and 1968 viruses, arose through slowly accumulating mutations in an avian virus rather than through a reassortment event. "We're looking at the approach of the 1957 and 1968 pandemics where there was a more sudden change," she said.

The most important lesson of the research so far, according to Katz, is "the knowledge that this process isn't simple, the procedure for the virus to acquire the properties of transmissibility." She said the CDC also created a hybrid that involved H3N2 virus surface proteins and H5N1 internal genes—the reverse of the hybrid she first described—and "that was not sufficient for transmissibility either. . . . That points to the fact that it's a complex interaction of the surface genes and the internal genes." Gerberding warned that the findings shouldn't lead to complacency.

"I'm not reassured from the public health perspective," she said. "This virus is still out there, it's still evolving, and influenza is always unpredictable. . . . So let's not use the word 'reassuring' with respect to what might happen with H5N1." Because of the risk that the reassortant viruses could spread, the research was done under stringent containment, involving Biosafety Level 3 with extra precautions, Katz said. ## **Criminal Charges Over the 'Swine Flu' To Be Biled in Austria On Monday**

Dear Dr Margaret Chan,

I am sending this email to inform you that I intend to file criminal charges on Monday Aril 27th against you as well as other employees in the WHO and allied organisations, for your role in exposing the populations of the world to the risk of a pandemic virus that could kill billions of people using laws to fight international racketeering influenced organised crime as well as the UN convention for the prevention and punishment of genocide.

As a public servant employed in an international organisation, the Director-General of the World Health Organisation based in Geneva, you have the duty as part of your official capacity to act at all times in such a way as to safeguard the health of the world's population, specifically to prevent the "misuse" of pandemic declaration by organisations, companies, government bodies or other entities intent on unleashing a pandemic virus and then carrying through a mass vaccination programme with contaminated material in order to gain political and economic advantages from mass murder.

Media reports indicate that your organisation is abusing its administrative structures, personnel and services to play up the danger of the swine flu virus to justify just such a mass vaccination programme with an untried and untested vaccine. The WHO has ordered all WHO officers to man the "Pandemic Control Room" 24/7 for the 1st time in response to the swine flu cases reported in the media yesterday, and is about to declare a "pandemic." The WHO "Pandemic Control Room" is designed to map and track the spread of a pandemic virus, and is thus equipped with super-computers tied to all U.N. member government's security forces.

This "control room" is where any declarations of "pandemic" will originate from, and I would be grateful if you could list the names of the people working in that control room. When WHO sends such a "declaration" to President Obama, FEMA and the Department of Homeland Security "Pandemic Task Forces" will be deployed according to my information. Each State Governor will be notified that the provisions of the Model State Emergency Health Powers Act (MSEHPA) will be implemented. This means that all Americans must consent to mass vaccinations, or be guilty of a FELONY crime.

Would it not, Dr Chan, be better just to ask people who refuse to wear a surgical mask if there is, indeed, a real danger of a pandemic? Why force through a vaccination on pain of being shot?

The legal situation is that anyone who refuses the vaccine, and/or resists forced relocation to a prepared "quarantine compound", can "legally" be shot and killed. (Justified "deadly force".) See <http://www.forhealthfreedom.org/Publications/Informed/RevisedModelState.html>

You must be aware of this facts.

This is such a drastic scenario that you in your capacity as a public servant must have real evidence of a dire threat to the population and be prove beyond a doubt that your actions will address that threat and that there is a good reason why you don't simply recommend people were surgical masks if they don't want to take the vaccination. From media reports, it seems that the new strain of swine flu is a synthetic structural recombinant,



it contains genes from birds, humans, and pigs from many different continents. It therefore is reasonable to assume it came out of a laboratory, specifically a bioweapons laboratory.

Wouldn't the WHO be better advised to investigate the lab that manufactured and released this synthetic virus and prosecute them or else recommend people wear surgical masks rather than declare a mass vaccination programme? According to a report in Fox News below, your assessment of the dangers of this swine flu is by far the most pessimistic with the CDC recommending just customary precautions. How do you explain that? How do explain why you have identified so many fatalities already while the Mexican government has confirmed only 16 from this new flu strain? What is the scientific basis for your identification? Are you using a correct procedure? Can you prove it in court that you are using the correct procedure and that simply recommending people wear surgical masks is not adequate.

Also, I note that the new strain of the swine flu has appeared in Mexico and America simultaneously, and under "mysterious circumstances" also indicating a deliberate, planned and coordinated release of the synthetic laboratory engineered viruses. Shouldn't you be investigating such a "mysterious" incident? Have you declared an investigation? Who are you investigating? Please give details?

WHO is obliged to exhaust all other avenues before declaring a pandemic and initiating a mass vaccination programme because you must -- as part of your duties to be informed as the holder of such an office -- know that the 1976 swine flu mass vaccination programme was abandoned by the US government because of the mounting evidence that the risk to the general public was greater from the vaccination programme than from the actual swine flu.

It is your especial duty, given this precedent in 1976, to make sure no mass vaccination programme is implemented unless that causes injury to the general public is implemented under your auspices by your declaring a pandemic prematurely and without having adequate safeguards in place to ensure the high quality and safety of any vaccine material. You also need to show that recommending surgical masks is not a viable alternative approach in dealing with any so-called pandemic. I contend that you are not fulfilling your duty to a) provide accurate information to the public about the threats posed to them by the swine flu and b) to ensure you do not declare a pandemic prematurely as a pretext to rush through a contaminated or faulty vaccine material that could result in death or injury to people as happened in 1976.

As a public servant whose body is currently investigation the involvement of Baxter and Avir in the release of bird flu pandemic material in Austria, you are obliged to be fully aware also of the details of this case and the role that a pharmaceutical company, namely Baxter, played in almost triggering a pandemic. You might also be aware of the criminal charges I filed against Baxter and other bodies, including the WHO, in respect of this case on April 8th with the Vienna City Prosecutor since they are available on a blog. The WHO reference center provided Baxter with the particularly lethal wild type bird flu virus that ended up contaminating ordinary human flu material and being distributed to 16 laboratories in Austria, the Czech Republic, Slovenia and Germany under a false label, and so nearly sparking a bird flu pandemic this winter in the estimation of experts and the media.

## **Virus mix-up by lab could have resulted in pandemic**

In the Baxter case of this winter, there is therefore a clear, well documented link between WHO and the release of pandemic bird flu material in Europe this winter. The WHO is, according to reports, conducting an investigation into Baxter and Avir's role in producing and distributing this material, but has so far not made public the results of its investigation or made recommendations in respect of stricter biosecurity rules for laboratories working with the highly pathogenic bird flu virus. Why not? I contend your failure to conduct a

full and detailed investigation into this incident, and to make those findings public or to make clear recommendations as to how to prevent a repeat of this incident is not merely a failure to perform your duty as a public servant but evidence of your role in covering up the real origin of the pandemic virus, specifically, in WHO's own reference center.

In my criminal charges filed with the Vienna City Prosecutor on April 8th, 2009, I alleged that Baxter deliberately tried to trigger a pandemic with the aim of profiting from it by sealing in advance lucrative contracts to supply a vaccination for the bird flu with the Austrian Health Ministry in 2006, specifically the contract sealed with Austrian Health Minister Maria Rauch-Kallat involved supplying 16 million vaccine shots in the event that WHO declared a bird flu pandemic. In Germany, a vaccination bird flu shot is mandatory ensuring more profits for pharmaceutical companies, and adding to the motivation for companies to trigger a pandemic because they will profit from it, and to take steps to exercise undue influence on members of WHO to declare a pandemic without adequate reason.

Referring to laws on racketeering influenced crime organisations, I argued that high offices in organisations such as the WHO have been annexed by criminal elements who are actually helping to further a criminal agenda of committing murder with the motive of robbery – albeit using covert bioweapons programmes. As a result of the actions of Baxter, at least 35 people in Austria and in the Czech Republic were given preventative treatment against bird flu and the ordinary human flu in hospital. This underlines that in the professional opinion of the medical personnel there was a real, concrete and specific danger from Baxter and WHO's contaminated material to the health of those individuals, such that administering medicines was considered necessary. I understand the Czech laboratory staff who came into contact with Baxter's contaminated and who first reported it on February 6th material were placed in quarantine.

Given the fact that this incident happened only a few weeks ago and your organisation is involved in it in as far as it supplied a) a lethal strain of the bird flu virus and b) is investigating the incident, it is your duty to be aware of all details, allegations of criminal intent, evidence for those allegations and refutations of those allegations because there are so many parallels with this new "swine flu" case, also involving a synthetic structure that has mysteriously appeared in two places simultaneously. In particular, you are obliged to be informed about the fact that Baxter uses biosafety level 3 regulations when handling the highly pathogenic bird flu virus that WHO sent the company from its reference center, and that under these biosafety 3 regulations an accidental contamination of the deadly bird flu virus strain you sent you're your reference center to Baxter with a human flu is virtually impossible.

You must also be aware of the research of Jeffery K. Taubenberger of the Department of Molecular Pathology, Armed Forces Institute of Pathology into the bird flu virus and specifically his reconstruction of the deadly strain of the bird flu virus from the genetic material retrieved from victims of the Spanish flu pandemic of 1918-1919. Although many researchers and NGOs issued warnings that resurrecting this lethal virus was dangerous to the public, the WHO has been one of the biggest supporters of continuing research into this bioengineered virus and into its "antidotes" spending millions of tax payers dollars on research and prevention programmes.

You must be aware that it was only last summer that scientists published in scientific journals evidence that showed that the bird flu can mix with the human flu virus to produce a pandemic virus in a laboratory situation. You must also be aware of the ongoing criminal investigation in Poland into the deaths of homeless people after they were given a bird flu trial vaccination by doctors and nurses last summer. There is therefore, I argue, ample evidence within the public domain to show that pharmaceutical companies and government organisations and other agents are knowingly and intentionally creating pandemic virus material and, as we saw in Austria, this winter unleashing it on the population, and trying to cover up their involvement.

Should you and WHO now declare a pandemic for the swine flu in the USA, and should people die as a direct result of the vaccination programme you initiate, or should there be significant evidence of harm or injury to

people as a direct result of the mass vaccination programme you initiate, as happened in 1976, you could find yourself charged not with a conspiracy to mass murder but with mass murder itself. Furthermore, the WHO, as far as I am informed, has published a study outlining the economic impact of a pandemic virus.

If you as part of your office help criminal organisations who have annexed high offices of state to carry out their crimes, to ignite and then declare a pandemic, that disrupts the economy, then you, other leading individuals working for WHO in an official capacity and WHO, as an organisation, could also liable not only for criminal charges but also for damages flowing from class action lawsuits filed not just by citizens of American but by citizens or company around the world that see their revenues decline as a direct result of the pandemic being unleashed, and the subsequent havoc to the economy.

If there is a pandemic declaration by WHO and mass deaths from the vaccination programme, I foresee a situation were you and the WHO could find thousands of people are filing criminal charges but also class action law suits. I contend there is evidence from the pattern of your activities concerning the Baxter case that you, under the color of your office while purporting to act in an official capacity, are actually acting on behalf of hidden crime interests intent on igniting a pandemic and misusing a declaration of a pandemic to gain political and financial advantages, a group which I designate as the Illuminati crime gang. The declaration of a pandemic by WHO has direct political and financial and other advantages to elements in the US government, especially elements I argue belong to the Illuminati/New World Order/CIA/Freemason crime gang, who are now being considered for investigation for sanctioning torture in Guantanamo in violation of the US and international law, specifically Donald Rumsfeld (who has financial connections with an anti bird flu Tamiflu producer), Richard Cheney and Alberto Gonzales.

The imposition of martial law will help anyone suspected of violating laws to torture to avoid prosecution in the United States, although a case is pending in Spain. I contend that you are abusing your office as Director General of WHO, knowingly and intentionally, to help the Illuminati achieve their political and financial goals. I contend there is already today, Saturday, evidence that you are intentionally manipulating information on the swine flu outbreak that allegedly started yesterday to play up the danger of a pandemic in order to justify the implementation of a mass vaccination programme while ignoring and suppressing information that indicates this response is not proportionate to the risk.

Finally, I ask you to please provide me by Monday 10am April 27th Central European Time in the form of email attachments, links, legal memos etc the following documentation so that I can review it before submitting fresh criminal charges related to this matter. Specifically, I ask you to send me or to instruct one of your personnel to send me

- 1) the studies you have to date on the swine flu vaccination you intend to inoculate the US population with, with clear evidence from respected scientific sources such as clinical trials reported in peer reviewed scientific journals as to their unequivocal safety;
- 2) information as to the genetic sequence of the swine flu strain detected by WHO in victims of the “swine flu” outbreak in Mexico and America so far;
- 3) information as to which companies WHO has contracted to provide a swine flu vaccination and under what terms and conditions, including quality assurance, financial terms and conditions;
- 4) a detailed account of all the safety procedures and independent reviews that WHO has put into place for ensuring any vaccination meets recognised standards of safety and quality;
- 5) documents proving that you have the legal authority in the case of a swine flu to declare a pandemic and enforce mass vaccinations for the swine flu on the population in the form of legal memos, rulings etc.

Please send all the above documents as email attachments.

If you miss the Monday deadline, I will argue in my submission to the court that you do not have the documents.

I ask you to make sure you keep a copy of the email to me so that you can prove to a court that you a) had all the requisite authority and documents and b) that you had them at hand and available for public and legal scrutiny at short notice in an emergency situation as is your obligation as a public servant. I will argue that if you have ordered your WHO officers to man the pandemic control room 24/7 from Friday April 24, as reported in the media, then you have an extra obligation to be on duty yourself this weekend and your failure to be on duty in the event of an emergency you have declared is a violation of the rules of conduct of your office.

As you have sufficient personnel at hand, I will argue, you can delegate this job of collecting the documents and materials I request in 1)-5) to a member of your staff and still be available to follow the "pandemic" which you claim is occurring. If you send me these documents after the Monday deadline, please make sure to keep a copy of the email so that you can prove in a court of law that you had the necessary authority, and documents proving you had that authority at hand, and could present them speedily as is required of a public servant in such an "emergency".

In case you wish to study the criminal charges I have filed on April 8th and wish to be able to better comprehend the legal basis for the criminal charges that I will file on Monday April the 27th, I attach a copy in German. I can also suggest my blog where I have published the charges in an English translation, though only the first 20 pages or so have so far been translated.

Mexico City closed schools across the metropolis of 20 million Friday after at least 16 people died and more than 900 others fall ill from what health officials suspect is a new strain of swine flu. World health officials worried that it could mark the start of a flu pandemic. The World Health Organization in Geneva, Switzerland said at least 57 have died in the outbreak, although it wasn't yet clear if this larger number of deaths was due to swine flu.

"We are very, very concerned," said Thomas Abraham, a spokesman for the agency. "We have what appears to be a novel virus and it has spread from human to human." If international spread is confirmed, that meets WHO's criteria for raising the pandemic alert level, he added. Abraham said WHO on Friday raised their internal alert system, allowing them to divert more money and personnel to dealing with the outbreak. "It's all

hands on deck at the moment." Abraham said. Mexico's Health Secretary, Jose Cordova, said only 16 of the deaths have been confirmed to have been caused by the new strain, through testing at the government's laboratories. Samples from 44 other people who died were still being tested. The health department put the total number of people sickened at around 943 nationwide.

Cordova said samples were sent to the U.S. Centers for Disease Control and Prevention in Atlanta, Georgia, to determine whether it's the same virus infecting seven people in Texas and California. As of now, tests show the flu is a "new, different strain ... that originally came from pigs." We certainly have 60 deaths that we can't be sure are from the same virus, but it is probable," Cordova told MVS radio in Mexico City. Cordova described a chilling new strain that had killed only people among the normally less-vulnerable young and mid-adult age range. One possibility is that the most vulnerable segments of the population — infants and the aged — had been vaccinated against other strains, and that those vaccines may be providing some protection.

But Dr. Anne Schuchat of the CDC said "at this point, we do not have any confirmations of swine influenza in Mexico" of the kind that sickened seven California and Texas residents. All seven U.S. victims recovered from a strain of the flu that combines pig, bird and human viruses in a way that researchers have not seen before. Cordova also told MVS radio in Mexico City that Mexican health officials can't be sure that the deaths "are from the same virus, but it is probable." Closing the schools kept 6.1 million students home from day care centers through high schools, and thousands more were affected as colleges and universities closed down. Parents scrambled to juggle work and family concerns due to what local media said was the first citywide schools closure since Mexico City's devastating 1985 earthquake.

Lillian Molina and other teachers at the Montessori's World preschool scrubbed down their empty classrooms with Clorox, soap and Lysol on Friday between fielding calls from worried parents. While the school has had no known cases among its students, Molina supported the government's decision to shutter classes, especially in preschools. "It's great they are taking precautions," she said. "I think it's a really good idea." Authorities advised capital residents not to go to work if they felt ill, and to wear surgical masks if they had to move through crowds. A wider shutdown — perhaps including shutting down government offices — was being considered.

"It is very likely that classes will be suspended for several days," Cordova said. "We will have to evaluate, and let's hope this doesn't happen, the need to restrict activity at workplaces." Still, U.S. health officials said it's not yet a reason for alarm in the United States. The five in California and two in Texas have all recovered, and testing indicates some common antiviral medications seem to work against the virus. Schuchat of the CDC said officials believe the new strain can spread human-to-human, which is unusual for a swine flu virus. The CDC is checking people who have been in contact with the seven confirmed U.S. cases, who all became ill between late March and mid-April. The U.S. cases are a growing medical mystery because it's unclear how they caught the virus. The CDC said none of the seven people were in contact with pigs, which is how people usually catch swine flu. And only a few were in contact with each other.

CDC officials described the virus as having a unique combination of gene segments not seen in people or pigs before. The bug contains human virus, avian virus from North America and pig viruses from North America, Europe and Asia. Health officials have seen mixes of bird, pig and human virus before, but never such an intercontinental combination with more than one pig virus in the mix. Scientists keep a close eye on flu viruses that emerge from pigs. The animals are considered particularly susceptible to both avian and human viruses and a likely place where the kind of genetic reassortment can take place that might lead to a new form of pandemic flu, said Dr. John Treanor, an infectious disease specialist at the University of Rochester Medical Center. The virus may be something completely new, or it may have been around for a while but was only detected now because of improved lab testing and disease surveillance, CDC officials said. The virus was first detected in two children in southern California — a 10-year-old boy in San Diego County and a 9-year-old girl in neighboring Imperial County.

It's not known if anyone is getting sick from the virus right now, CDC officials said. It's also not known if the seasonal flu vaccine that Americans got last fall and early this year protects against this type of virus. People should wash their hands and take other customary precautions, CDC officials said.

## THE SWINE FLU FIASCO

In 1976 I was working in the far north of Australia amongst Aborigines. I observed, in one community of only a few hundred people, when they were given the flu vaccine (probably the Victorian strain but this detail does not really matter because nobody outside a few selected individuals really knows what is in any particular batch), six men died suddenly soon afterwards. They were not all 'old'. One was in his early twenties. A few weeks later, in another community I found that individuals with heart or potential heart problems or diabetes were particularly likely to drop dead soon after being given the vaccine.

Obviously, there was a problem with some batches of the flu vaccine. A few months later I was in America. President Ford had been told by his health advisers that there was going to be a huge epidemic of 'swine flu', that this could kill may thousands and the only way to prevent this catastrophe was to vaccinate the entire population of America – every man woman and child - with a specific vaccine. So the vaccine was manufactured and the biggest vaccination campaign in history was begun. I was concerned because the vaccine could not be properly tested in a short period. None of the recipients would know anything about what they were being injected with and the chances were that many would die suddenly. Furthermore, it was extremely unlikely that an epidemic of swine flu would occur. So I spoke out. At first the newspapers got hold of what I said and headlined, 'Australian Physician Call It Mass Murder'. Then I appeared on Kathy Crosby's television program.

Watching that was a man in New York who did not like a gentleman named Gambino the Mafia boss. Gambino was about 70 years old and had a history of heart problems. It was a simple matter to get someone to persuade Gambino to have the flu shot and Gambino obliged by dropping dead. The newspapers got it right when they stated, 'Mafia Flu Jab Conspiracy.' People were dropping dead in the buildings where they received their shots. Others became paralyzed. The whole program ground to a halt. President Ford decided to settle the matter quickly. In front of the whole world, on television, he rolled up his sleeve and 'had his shot'. I claimed at the time that he was given a 'dud' shot and I am certain that this was actually done. Then President Ford invited all the news media men and women who were milling around to line up and have their shots. Only one man volunteered and he happened to be the White House press secretary. All the others refused the invitation.

There was not a single case of swine flu. There never was going to be an epidemic of swine flu. How was it that the world's most powerful man with the world's greatest department of health got it all so wrong? No one really knows the answer but what ever it is it is certainly not clean and tidy. Furthermore, as far as I know I was the only practicing doctor who spoke out against it and warned about almost certain consequences. How was it that a doctor with only basic qualifications and not even the possessor of American citizenship stood out alone? There was at least one researcher, Anthony Morris, who did try to speak out but he was at the time censored and censored very hard.

This, therefore, is a classical example of how only one man got it right and everyone else got it wrong. This is an important consideration because, when the subject of vaccines is discussed the fact that the vast bulk of the medical establishment states that something is so it is not, in reality, necessarily so. If the establishment can get something so vast and important as the swine flu vaccine campaign so wrong then it is logical to reason that they could also get a lot of other things wrong. At least it gives reasons to doubt what the establishment claims



to be fact. If doctors and members of the general public considered this fewer errors would be made and fewer individuals would suffer unnecessarily.

## **H1N1-H5N1 Flu Outbreak Implicates Anglo-American**

### **“Vaccine Pipeline” Says Expert Dr. Leonard Horowitz**

Los Angeles, CA— Skyrocketing stock values of Novavax, Inc.,<sup>1</sup> precipitated by dozens of flu deaths in Mexico, implicates a leading Anglo-American network of genetic engineers in a conspiracy to commit genocide, according to a Harvard trained expert in emerging diseases, Dr. Leonard Horowitz. Dr. James S. Robertson, England’s leading bioengineer of flu viruses for the vaccine industry, and avid promoter of U.S. Government funding for lucrative “biodefense” contracts, along with collaborators at the US Centers for Disease Control & Prevention (CDC), helped Novavax, Inc., in Bethesda, Maryland, produce genetically-modified recombinants of the avian, swine, and Spanish flu viruses, H5N1 and H1N1, nearly identical to the unprecedented Mexican virus that has now spread to the United States. **The outbreak was precisely timed to promote the company’s new research and huge vaccine stockpiling contracts,** according to Dr.

Horowitz.<sup>2</sup> Scientists at the U.S. Centers for Disease Control (CDC) are implicated through collaborations and publications involving private contracts with Novavax, a company that obtains its “biosimulars” through CDC Influenza Branch director, Ruben O. Donis, and Dr. Rick Bright, previously working with Donis at the CDC, now Novavax’s Vice President of Global Influenza Programs.

**Evidence for the conspiracy to commit deadly duplicity in the vaccine industry includes the genetic markers on the novel flu virus now spreading from Mexico to America.** The virus is “genetically different from the fully human H1N1 seasonal influenza virus that has been circulating globally for the past few years,” according

to Reuters and government officials. “The new flu virus contains DNA typical to avian, swine and human viruses, including elements from European and Asian swine viruses.”<sup>3</sup> “That is a description that is pathognomonic, or diagnostic, of a virus that came from Robertson’s circle of friends,” Dr. Horowitz claims. “No other group in the world takes H5N1 Asian flu infected chickens, brings them to Europe, extracts their DNA, combines their proteins with H1N1 viruses from the 1918 Spanish flu isolate, additionally mixes in swine flu genes from pigs, then ‘reverse engineers’ them to infect humans. The end product that Reuter’s describes could only end up in Mexico via the United States from Britain in care of the CDC. **Ruben Donis at the CDC had to have sent them to Novavax, where Rick Bright’s team is now implicated in a conspiracy to commit genocide—the mass killing of people for profit.**”

Novavax’s preliminary report in the Journal of Virology, with co-authors from the CDC in Atlanta, was posted online at the precise time Mexican officials began reporting deaths from this new strain of flu that is clearly an unprecedented recombinant of at least three H5N1 and H1N1 strains. Novavax’s Johnny-on-the-spot vaccine was prepared under the CDC’s “fast track” approval process speciously using these three strains never known to infect any human in Mexico. **Therefore, the statistical probability this virus came from this company of “experts” is extremely high.** Alternatively, anticipated arguments the virus arrived in Mexico by serendipity, at this precise time in Novavax’s history, is ridiculously remote.

“These doctor’s conflicting corporate, scientific, and financial interests evidence criminal malfeasance,” said Dr. Leonard Horowitz, an internationally known humanitarian, award winning consumer health activist, and author of sixteen books including, *Emerging Viruses: AIDS & Ebola—Nature, Accident or Intentional?* (1998, [tetraedron.org](http://tetraedron.org); 1-888-508-4787), His book, and associated scientific publications, have been cited by numerous authorities as providing compelling evidence the AIDS virus came from a lab.

“The most chilling evidence against the Robertson-Novavax (RN) vaccine pipeline, besides Robertson being the “gatekeeper” for multi-billion dollar vaccine stockpiling deals, is Robertson’s influence over the European Medicines Agency (EMA)—a quasi-corporate quasi-scientific think tank serving the European [Economic] Union and drug industry’s special interests,” Dr. Horowitz said. Dr. Robertson is the Principal Scientist in the Division of Virology at the National Institute for Biological Standards and Control (NIBSC), akin to the USFDA in the UK. During a meeting in April, 2006, discussing the standardization of influenza vaccines on behalf of the World Health Organization (WHO), it was disclosed, “the NIBSC is involved in the serological testing of vaccine trials; the preparation and distribution of influenza viruses to vaccine manufacturers; and the coordination of EU strain selection[s].” Participants disclosed the EMA persuades vaccine makers to bank on pandemics, and “invest in pandemic vaccines with the introduction of mock up files,” which is their unassuming way of describing new laboratory engineered influenza viruses also referred to as “biosimilars.”<sup>4</sup>

The EMA waves regulatory fees as an additional incentive to attract more business for allegedly “biodefense.”<sup>4</sup> Dr. Robertson, the holder of intellectual property (IP) rights to the genetic technology used to produce the H5N1 and H1N1 “mock up files” used to develop Novavax’s vaccine, waived his ownership of the technology during the company’s research phase with a guaranteed payoff “when the vaccine is commercialized.” Robertson’s “Material Trade Agreement” (MTA), covering the transfer of these “biosimilars” to Novavax, is expected to return millions of dollars when the vaccine is sold to governments worldwide. <sup>4</sup>

Novavax’s commercialization and promotions of their vaccine is largely based on media hype fanning fears and markets for their avian flu, Spanish flu, and swine flu concoctions. Never before this outbreak has such a virus, combining the three most feared flu strains, been identified. Mexico’s killer, therefore, evidences a laboratory creation sourcing from either Novavax’s lab directly, or their partners at the CDC and NIBSC who maintain multi-million-dollar incentives. The company’s synchronously timed professional publications, mass media releases, product representations and commercialization, evidence financial motives to commit duplicity and mass murder.

Days ago, officials at the CDC expressed serious concerns about this novel flu strain causing a deadly pandemic, not disclosing their obvious knowledge that the outbreak must have sourced from the materials used in their cooperative studies with Novavax.<sup>5</sup> “These doctor’s conflicting corporate, scientific, and financial interests evidence criminal malfeasance. Killing dozens of people for publicity and duplicity in public health; to increase marketability of their new vaccine, is best described as serial homicide to advance genocide—the mass killing of people for profit,” Dr. Leonard Horowitz explained. The most chilling evidence against Dr. Robertson’s EU research team, besides him being the gatekeeper and chief promoter for multi-billion dollar flu vaccine stockpiling deals, and besides his collaborators being caught red handed here by hard science and common sense, is his stated position that he believes it is wise to “prime” populations worldwide by releasing viruses he and his colleagues are creating. This warning comes from a April 27, 2006, scientific discourse in which Dr. Robertson, and members of his WHO working group, recommended his “biosimilars” be “used to prime the population in advance of the pandemic reaching the UK.”

In other words, the doctors that hold infectious disease responsibility for the world have already decided to loose their viruses on unwitting populations in advance of threatened outbreaks.
